<u>The Council</u> approved its position at first reading, in accordance with Article 294(5) of the Treaty on the Functioning of the European Union, with the <u>Danish and Austrian delegations</u> abstaining (Legal basis: Article 114 of the TFEU).

Statement by the Danish delegation

"Denmark regrets that the Council has been unable to reach agreement on Member States having an independent right to restrict or prohibit the placing on the market and use of biocidal products on their own territory, where national conditions indicate an unacceptable risk to the environment and health.

For that reason Denmark wishes to abstain from voting for the common position and reserves the right in further negotiations with the European Parliament to strive for the inclusion of such a right when the proposal is finally adopted."

Statements by the Commission

Comitology

"In a spirit of compromise, the Commission will not stand against a qualified majority vote in favour of the Presidency text. However, the Commission would underline that it does not share the views of the Council that the measures for the approval of active substances (Article 9) and for rules on fees payable to the European Chemicals Agency (Article 79(1)) are of an implementing nature and thus fall under Article 291 TFEU. As regards both these matters, the Commission is of the view Article 290 is the appropriate procedure given that they entail measures of general application which would modify or supplement the non-essential elements of the Regulation."

Resource implications

"The extension of the scope of the Union authorisation together with additional tasks allocated to the European Chemicals Agency, the shorter deadlines and the increased frequency of renewals for active substances will necessarily result in a significant increase in the workload of the Agency and the Commission. At the same time, the workload for national authorities will accordingly be reduced as a result of a wider scope of Union authorisation. In light of the increased workload, the Agency and the Commission will need additional financial and human resources to ensure effective implementation of the Regulation. In view of this, the Commission calls on the Council to address these requirements under the new financial perspectives. The Commission is prepared to work with the Council on a suitable solution."

The Council adopted the conclusions contained in document 11308/11.

The Commission expressed its strong support for the Council Conclusions, considering the text well balanced and in line with Commission's intentions.

The Council also discussed the expectations regarding the upcoming Blueprint to Safeguard Europe's Water Resources, scheduled by the Commission for 2012.

Most delegations called upon an integration of water policy objectives in other areas (in particular the CAP).

Some delegations highlighted the need to harmonize what already exists rather than create new legislative instruments. They also underlined prevention activities with regard to extreme events (notably as far as drought and floods are concerned).

Many delegations urged that regional differences be taken into account, while others commented on the need for adequate instruments and financial mechanisms.

Bulgaria, Denmark, Germany and Italy made statements as set out hereafter:

Statement by Bulgaria

<u>Bulgaria</u> endorses the EU Biodiversity strategy to 2020 and will consider its targets when the sets of "*current assessments*" of the conservation status of the habitats and species for Bulgaria, as per the requirements of the Habitat Directive and of the species status, as per the requirements of the Birds Directive, are clearly defined. It is very important to continue the discussion on the targets and the actions of the Strategy for the purpose of ensuring effective and coherent implementation of the EU Biodiversity Strategy to 2020.

This statement is to be attached to the Council Conclusions on EU Biodiversity Strategy to 2020 as agreed on 21 June, 2011 and will constitute an integral part of the said Conclusions.

Statement by Denmark

<u>Denmark</u> welcomes the European Commission's Biodiversity Strategy to 2020 and can support the Council Conclusions on the strategy.

The strategy could potentially have very significant economic consequences. The EU-Commission has not put forward a specific cost estimate but according to the strategy and the impact assessment the annual costs could amount to several billion euros. It is therefore of utmost importance that the strategy, its targets, instruments and financial consequences for the EU and the individual Member States are analysed and discussed very thoroughly before any concrete decisions on the strategy are made.

The current Council conclusions on the strategy do not in any way prejudge concrete decisions stemming from the strategy, which have economic consequences for the EU and individual Member States.

Statement by Germany

<u>Germany</u>'s agreement to the conclusions of the Environment Council is without prejudice to its opposition to a Framework Directive on soil protection for reasons of subsidiarity.

Statement by Italy

<u>Italy</u> states that the text of the Conclusions on the EU Biodiversity Strategy to 2020, as agreed on 21 June 2011, does not imply any automatic support for the targets indicated in that Strategy, which would have to be discussed further in greater detail by all the competent institutional bodies of the European Union.
