<u>The Council</u> approved its position at first reading, in accordance with Article 294(5) of the Treaty on the Functioning of the European Union (Legal basis: Articles 209 and 212 of the TFEU).

Statements by the Council

Statement 1: Iceland

"The Council takes note of the issuance of the reasoned opinion of the EFTA Surveillance Authority (ESA) which states that Iceland has failed to comply with obligations resulting from the Deposit Guarantee Directive and the EEA Agreement. The Council underlines the importance of this reasoned opinion and encourages Iceland to take all steps necessary to swiftly fulfil all its EEA obligations."

Statement 2: Risk capital

"Risk capital is an important financing instrument to promote, notably in the Mediterranean, inclusive economic development and growth, in particular to support SMEs which are key drivers for job creation and innovation."

Statement 3: Kosovo

"The references to Kosovo in this Decision to grant a European Union guarantee to the EIB against losses under loans and loan guarantees for projects outside the European Union are without prejudice to the Member States' positions on its status."
