The Committee had a round table to grasp views and political orientations from delegations on the main issues highlighted by the Presidency compromise text.

Almost all delegations welcomed the Presidency compromise text, confirming that good progress had been made, that it was heading in the right direction and encouraging the pursuit of the work on this dossier. However, a number of delegations considered that the Presidency compromise text should still provide more flexibility to ensure the sustainable growth of the organic sector (e.g. by maintaining the possibility to set mixed farms, to use non organic seeds). Moreover, some member States asked the Italian Presidency to discuss compromise text at the expert level.

The Commission also welcomed the Presidency compromise text which was ambitious, and assured delegations that the new Commissioner was ready to have a "fresh look" at the proposal. The Commission representative also indicated its willingness to show some flexibility in order to move forward rapidly on this dossier.

The Council Legal Service explained that the original Commission proposal raised serious concerns as regards the structure of the text and the use of delegated acts, and took the view that the Presidency's redrafted compromise text represented in this respect a step in the right direction.

The Presidency concluded that it would table this dossier at a next SCA in light of the views expressed by delegations.
