## INFORMATION NOTE

Subject: Partial renewal of the members of the Court of Auditors (2018)  
- Procedure

---

1. The term of office of eight members of the Court of Auditors will expire on 28 February 2018, and that of one member on 31 December 2018.
2. Article 286(1) and (2), first subparagraph, (TFEU) state that:  
  
*"1. The Members of the Court of Auditors shall be chosen from among persons who belong or have belonged in their respective States to external audit bodies or who are especially qualified for this office. Their independence must be beyond doubt.*  
  
*2. The Members of the Court of Auditors shall be appointed for a term of six years. The Council, after consulting the European Parliament, shall adopt the list of Members drawn up in accordance with the proposals made by each Member State. The term of office of the Members of the Court of Auditors shall be renewable".*
3. In his letter dated 3 April 2017 (see Annex I to this note), the Secretary General of the Court of Auditors draws the attention of the President of the Council to the fact that nine members of the Court will be reaching the end of their term of office in 2018 and asks to be informed about the timetable for appointing members to replace them.

4. In order to ensure continuity of the Court of Auditors' work, the Council Decisions appointing the members of the Court should be adopted no later than the end of January 2018 (eight members) and the end of November 2018 (one member) respectively.

To that end, the procedure for the appointment of the members should start in sufficient time for the Council to take its decision to consult the European Parliament in October 2017 and in July 2018 respectively. The Member States concerned should therefore send their proposals to the General Secretariat no later than **16 September 2017** and **16 June 2018** respectively<sup>1</sup>.

5. The Member States should send a letter with their proposals accompanied by the candidate's *curriculum vitae*, which should not contain any personal data (e.g. marital status, family situation, home address, etc.) in an Annex I. The candidate's contact details should be given in an Annex II.

Delegations are requested to also e-mail their proposals in **Word format**, to **[nominations@consilium.europa.eu](mailto:nominations@consilium.europa.eu)**.

The letter and curriculum vitae will become part of a document that will be available to the public.

6. Delegations will find a draft reply to the letter from the President of the European Court of Auditors in Annex II to this note. This draft reply is to be approved by COREPER in accordance with Article 19(7) of the Council's Rules of Procedure.
