The Committee granted a broad approval on the proposed texts, and gave a mandate to the Presidency, including to transmit to the EP a letter complementing the scope of the consultation on the ORD proposal, in order to start discussions with the EP. The Committee gave its broad approval on the text of the draft Own Resources Decision as set out in 10025/20 which will be submitted to the European Parliament.

The Council Legal service confirmed that a broad approval on the proposed texts, and giving a mandate to the Presidency, including transmitting to the EP a letter complementing the scope of the consultation on the ORD proposal in order to start discussions with the EP, is only an intermediate procedural step and does not prejudice the final positions of the delegations when adopting the relevant proposed texts in the Council.

The Commission confirmed that a Memorandum of Understanding will be signed between the Commission and Member States on the implementation of the Own Resources decision and in particular operational modalities for the implementation of article 6-5 concerning cash calls.
