1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 15290/12 FIN 807 SOC 852, accompanied by the corresponding proposal for transfer of appropriations No DEC 41/2012 within Section III - Commission - of the general budget for 2012, as recorded in document 15291/12 FIN 808.

2. The proposal aims at mobilising an amount of EUR 2 658 495 under the EGF to meet an application from Italy to deploy the Fund in connection with redundancies in powered two-wheeler industry. Italian manufacturers of mopeds and motorcycles have suffered from a significant drop in the domestic and European demand and growing exports from Asia that resulted in a significant decrease in the domestic production as a consequence of a global financial and economic crisis.

The purpose of the proposed transfer is to move an amount of EUR 2 658 495 in commitment appropriations from Article 40 02 43 (*Reserve for the European Globalisation Adjustment Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*) and EUR 1 160 745 in payment appropriations from Article 04 04 15 (*European Progress Microfinance Facility*) to Article 04 05 01 (*European Globalisation Adjustment Fund*). The rest of the necessary payment appropriations will be made available through draft amending budget No 6/2012.

3. At the simplified trilogue procedure provided for in Point 28 of the Interinstitutional Agreement of 17 May 2006, an agreement was reached on the mobilisation of the EGF and on the amount proposed by the Commission.
4. The Budget Committee examined both proposals at its meeting on 5 November 2012.
5. Following that examination, the Budget Committee agreed, by a qualified majority to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the Decision on the mobilisation of the EGF, as set out in document 15290/12, following the adoption of amending budget No 6/2012;
 - approve the proposed transfer of appropriations, as set out in document 15291/12;
 - approve the annexed draft letter to the European Parliament and to the Commission to that effect.
