# amending Decision 2009/935/JHA as regards the list of third States and organisations with which Europol shall conclude agreements

### THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Decision 2009/371/JHA of 6 April 2009 establishing the European Police Office (Europol)<sup>1</sup>, and in particular point (a) of Article 26(1) thereof,

Having regard to Council Decision 2009/934/JHA of 30 November 2009 adopting the implementing rules governing Europol's relations with partners, including the exchange of personal data and classified information<sup>2</sup>, and in particular Articles 5 and 6 thereof,

Having regard to Council Decision 2009/935/JHA of 30 November 2009 determining the list of third States and organisations with which Europol shall conclude agreements<sup>3</sup>, and in particular Article 2 thereof,

Having regard to the opinion of the European Parliament<sup>4</sup>,

### Whereas:

- **(1)** It is for the Council to determine, pursuant to point (a) of Article 26(1) of Decision 2009/371/JHA, the list of the third States and organisations with which Europol shall conclude agreements ("the list"). Pursuant to Decision 2009/371/JHA, the list is set out in the Annex to Decision 2009/935/JHA.
- It is for Europol's Management Board to review when necessary the list and to decide (2) whether to propose to the Council amendments thereto.
- In its meeting of 3-4 October 2012, Europol's Management Board decided to recommend (3) to the Council to add certain third States to the list, outlining the operational need to do so.
- **(4)** Decision 2009/935/JHA should therefore be amended accordingly,
