"The Commission maintains its position and is therefore opposed to the Council's amendment replacing the legal basis of Article 43(2) in conjunction with Art. 218(6)a with Article 43 (without mentioning the paragraph) in conjunction with Article 218(6)a.

The Commission also considers that "Article 43(2) in conjunction with Article 218 (6)(a) should be used as the correct legal basis, in those cases where international fisheries agreements shall be concluded with the consent of the European Parliament, given that the material legal basis of Article 43(2) determines the requirement of the consent of the European Parliament pursuant to the operational legal basis of Article 218(6)(a).""

<u>The Committee</u> discussed the compromise package proposed by the Presidency, as in document 16185/12, with a view to preparing the first informal trilogue on 28 November 2012. <u>The Committee</u> could not give a flexible mandate to the Presidency to provide for the inclusion in the Regulation of the "<u>maximisation of the socio-economic benefits from the programmes through the development of applications</u>". Although some Member States could support the Presidency proposal, a substantial number of other Member States expressed their reservations, while waiting for the outcome of the current discussions on the Multiannual Financial Framework 2014-2020.

<u>The Committee</u> discussed the item. The Presidency concluded that :

- there was a qualified majority in favour of the Regulation on allocation of fishing opportunities (with ES, LV and PT opposing and EL abstaining);
- there was unanimity to change the legal basis in the decision on conclusion of the Protocol.

<u>DK</u> lifted its parliamentary scrutiny reserve. <u>UK</u> maintains a parliamentary scrutiny reserve.

The Chair informed <u>the Committee</u> of the main points discussed at the 2nd trilogue on 20 November 2012, namely Computer Emergency Response Teams, possible operational tasks, ENISA support to be provided at its discretion or upon Member States' request, possible extension of ENISA budget in relation with which the Commission was invited to provide a cost assessment of possible extra tasks, as well as what the European Parliament sees as the most important political issues i.e. the establishment of an Executive Board, the establishment of branch offices, the appointment of the Executive Director and the duration of ENISA mandate. While the atmosphere of the meeting was generally constructive one had to note the negative assessment drawn by the EP representative at the end of the trilogue.

The next trilogue is scheduled for 4 December 2012.

<u>The Committee</u> reached agreement on a mandate, on the basis of the text set out in the third and fourth columns of document 16107/12, which should enable the Presidency to conclude the negotiations with the European Parliament on the occasion of the third trilogue on 27 November 2012. As stressed by several delegations this mandate is already streching their flexibility e.g. as regards the possibility to accept binding time limit for one of the phases of the permit granting procedure or the insertion of provisions on operational coordination. The Presidency took note of the limits and comments attached to the flexibility with which this mandate was accepted.
