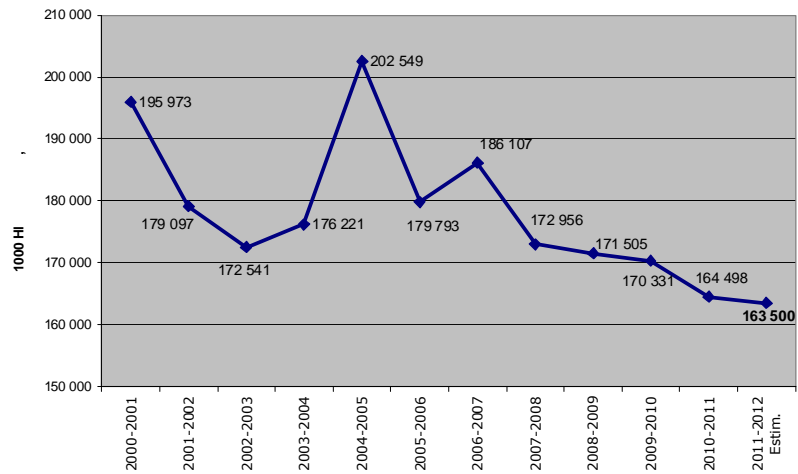

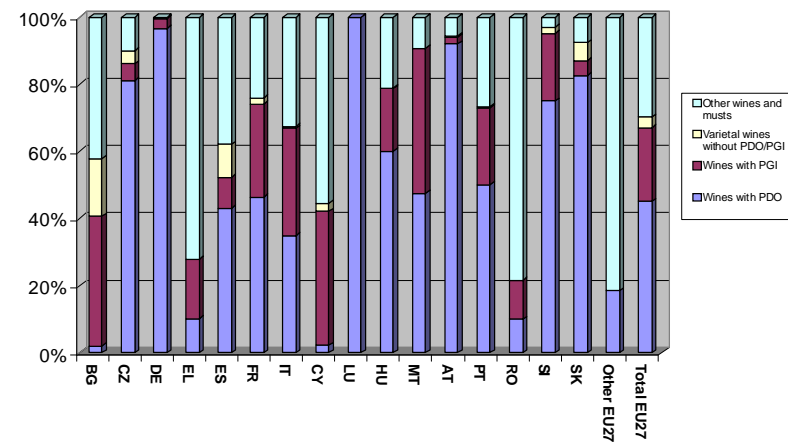

Situation June 10th 2012

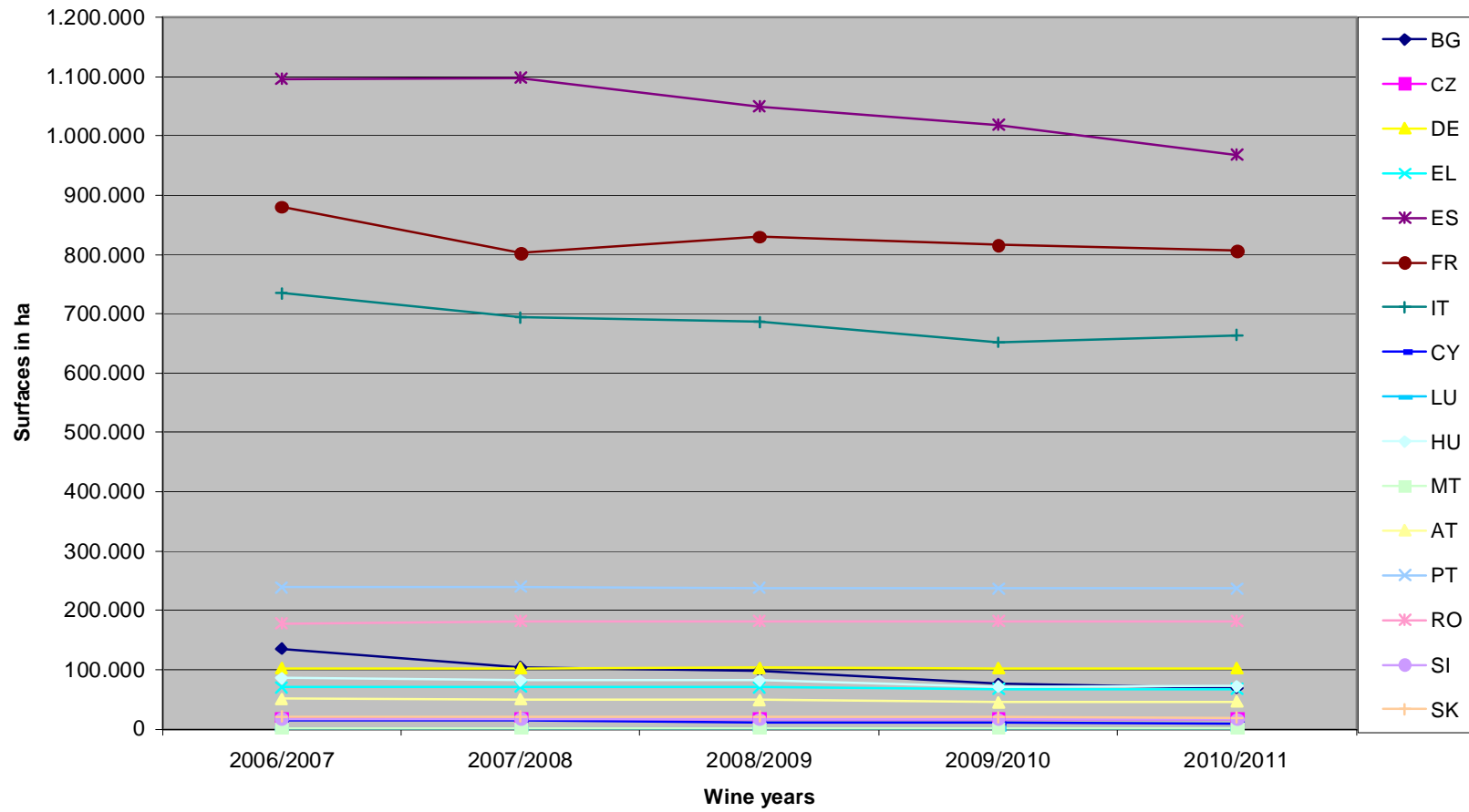


2011-2012 EU Wine production by category (PDO, PGI, VAR, others)

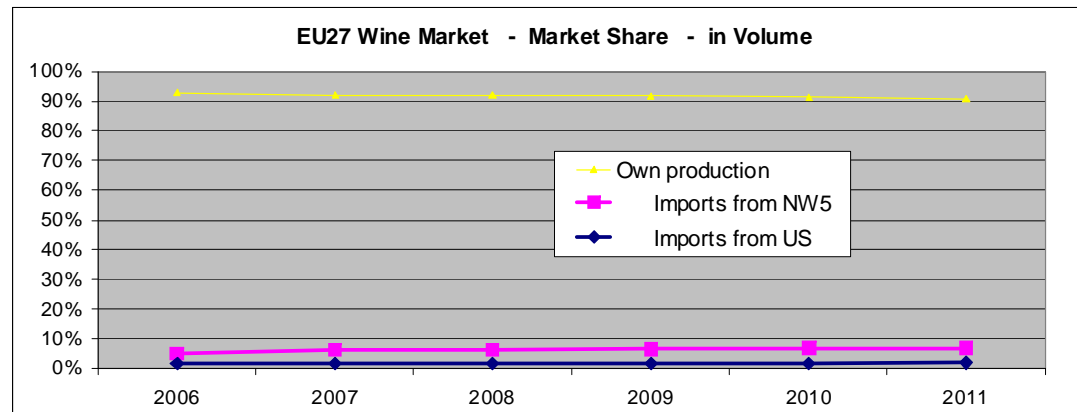

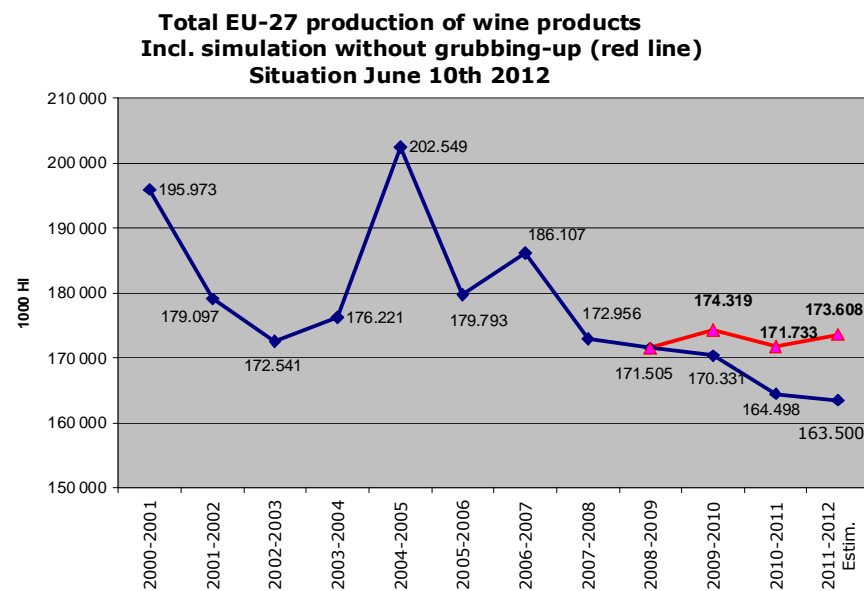

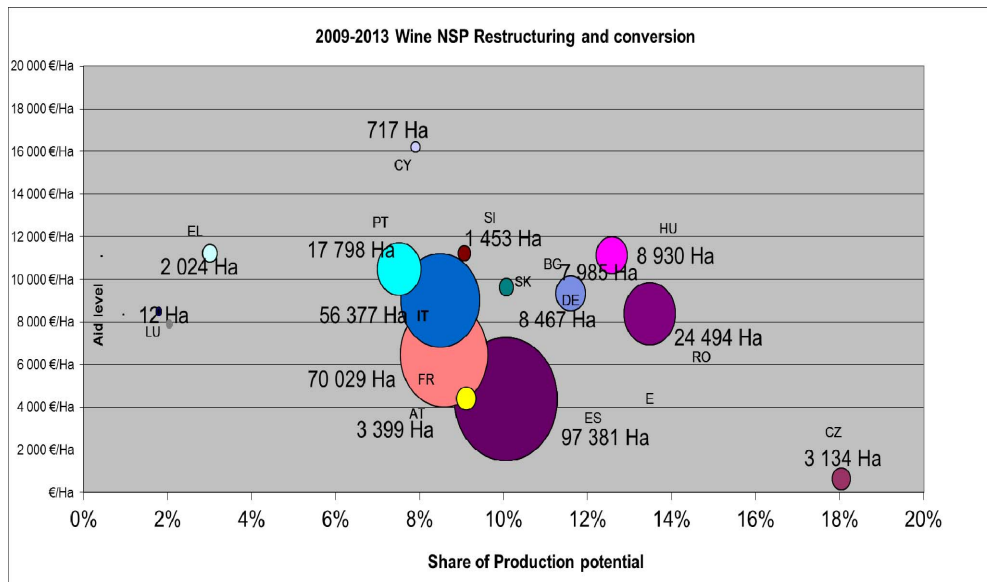

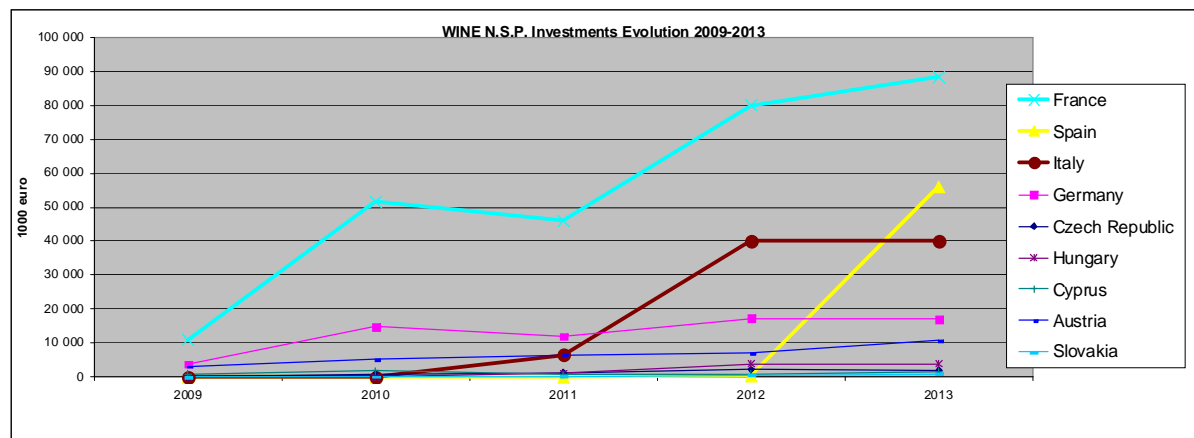
