Subject:	Summary record of the meeting of the European Parliament Committee on Civil Liberties, Justice and Home Affairs (LIBE), held in Strasbourg on 10 December
	2012

The meeting was chaired by Mr LÓPEZ AGUILAR (S&D, ES). The agenda was adopted without amendment.

Item 2 on the agenda

Chair's announcements

- Ms HEDH (S&D, SE) was nominated as rapporteur on the proposal amending Regulation EC 273/2004 on drug precursors.
- Mr PAPANIKOLAOU (EPP, EL) was nominated draftsperson on the "2011 discharge: performance, financial management and control of EU agencies".

The Chair also announced that the EP new rules of procedures 70 and 70a had entered into force on 10 December ("Guerrero Salom report"). He mentioned that these rules will imply some changes in LIBE practice of orientation votes. He added that, for the three votes planned that day (see below), LIBE coordinators had decided to use the procedure mentioned in the new rule 70 paragraph 2, subparagraph 12a "by way of exception, where the committee considers it duly justified to enter into negotiations prior to the adoption of the report in committee, the mandate may consist of a set of amendments ...".

He explained that it was justified since LIBE could not adopt the MFF reports without knowing the figures and LIBE also wanted to maintain a consistent approach between all MFF reports in the JHA area, four of which had already been adopted as "orientation votes" at the LIBE meeting of 27 November.
