The Council, on the basis of the documents listed on the Agenda together with docs. 10414/12 and 11366/12 reached a general approach on the proposal for a Regulation of the Common Fisheries Policy and for the proposal on a Regulation on Common Organisation of the Markets (docs. 11322/12 and 10415/12), with Sweden, Slovenia, Portugal, Malta and the Netherlands opposing, and Greece abstaining.

The Council made statements as laid down in addenda to docs, 11322/12 and 10415/12, and took note of the Commission's statement (doc. 11322/12 ADD 1). The Commission maintained its reserve on the compromise reached on both texts.

Concerning the proposal on a European Maritime and Fisheries Fund the Council took note of the Presidency's progress report (doc. 10276/1/12 REV 1). The Presidency is to inform the European Parliament about the general approaches and prepare further Council discussion on the proposal on a European Maritime and Fisheries Fund.
