"The Commission considers that an act adopted as a legislative act under the former Treaty (EC Treaty) must be amended by way of the now existing ordinary legislative procedure under TFEU.

For these reasons, the Commission considers that Articles 9 and 12 of Regulation 1342/2008 (the Cod Plan) cannot be amended by the Council on the basis of the non-legislative procedure of Article 43(3) TFEU. Furthermore, the material content of Articles 9 and 12 of the Cod Plan cannot be construed as being covered by the terms "measures on the fixing and allocation of fishing opportunities".

The Presidency's proposal to split the Commission's proposal and adopt under Article 43(3) TFEU the amendment to Articles 9 and 12 of the Cod Plan would be in breach of the Treaty. In these circumstances, the Commission maintains its original proposal including the legal basis of Article 43(2) TFEU, and reserves the right to avail itself of the legal remedies provided by the Treaty to contest the Council's amendment to the Cod Plan."
