Subject:	Summary record of the meeting of the European Parliament's <b>Committee on Budgets (BUDG)</b> held in Brussels on 18 December 2012

---

The meeting was chaired by Mr LAMASSOURE (PPE, FR).

***Item 2 on the agenda***  
**Chairman's announcements**

Financial Regulation - Delegated act

Mr LAMASSOURE informed BUDG members that up to now there was no objection to the delegated act concerning the new Financial Regulation. In case no objection was issued by 29 December, it would be published and enter into force on 1 January 2013.

Interparliamentary Committee Meeting

The Chairman announced that the next meeting would take place from 28 to 30 January 2013. The meeting would allow members of national or regional parliaments to express themselves on the Annual Growth Survey adopted by the Commission, which set out EU priorities for the coming year. The meeting of the European Council in March will then provide policy orientations and, in April, Member States will submit their plans for sound public finances. After assessment by the Commission, the process will end at the end of June by the Council's country-specific recommendations.

### Rapporteurs for 2014 budgetary procedure

Mr LAMASSOURE informed BUDG members that Ms JENSEN (ALDE, DK) would be the rapporteur for Section III (general budget) and Ms HOHLMEIER (PPE, DE) for the other institutions.

### New European Authorities for the supervision of financial activities

The Chairman announced that a meeting organised by Ms HAUG (S&D, DE) on the three new agencies would take place on 10 January 2013.

### ***Item 4 on the agenda***

#### **Budget 2014 - Exchange of views on the Guidelines Budget 2014 - Other Sections**

Co-rapporteurs: Ms JENSEN (ALDE, DK) and Ms HOHLMEIER (PPE, DE)

Mr LAMASSOURE underlined that the first question was the point of issuing guidelines, as no agreement had been reached on MFF.

Ms JENSEN was in favour of presenting guidelines even in the absence of MFF. She intended to issue a first draft to be discussed in January. In any case, she considered that a first assessment of the budgetary procedure under the Lisbon Treaty was of interest with regard to the preparation of the Spring budgetary trilogue.

Mr LAMASSOURE recognised that guidelines could be an occasion to give the alarm that, in case the European Council maintained about the same figures as discussed in November for the next MFF, payments would go beyond the envisaged ceiling by 2014. He also underlined that it was time to include a debate on the revenue aspect of the annual budgetary procedure and to make public those data, notably concerning national contributions.

Mr FÄRM worried about the possible management of those guidelines together with other procedures: budget 2013, European Semester and MFF, all in January and February. Even if he was not opposed to the issue of guidelines, he considered that they were time-consuming and complicated to coordinate.

Ms TRÜPEL (GREENS, DE) insisted on the need to communicate to the outside world that it was true that the EP requested more money for EU but that the EP was also in favour of better spending - shifting appropriations towards areas where it was important to invest in this time of crisis. She also underlined the importance of timing when issuing positions so as to ensure the best impact.

Mr LAMASSOURE recognised that 2014 guidelines were an occasion to send a message on MFF. However, a specific message on MFF was envisaged at the beginning of 2013 and would be discussed at the next meeting of the contact group with Mr SCHULZ on 10 January. He agreed with Ms TRÜPEL on the need for better spending but underlined the EP difficulties with defining negative priorities.

Ms JENSEN agreed that it was important to focus on 2014 needs and that 2014 guidelines would not substitute for MFF negotiations. She insisted on the need for sufficient financing in this period of crisis.

Ms HOHLMEIER, rapporteur for the other institutions, intended to insist in the guidelines on the need to take into account the economic and financial situation in Member States which implied restrictions in the EP budget. She wanted to focus on structural reforms, as needs could be covered not only by increased financing but also by improved structure. She envisaged possible further savings by developing translation and interpretation on demand, by reducing paper printing, by creating working groups on the issue of savings, by improving interinstitutional cooperation notably in translation and by supervising building policy. She envisaged the same guidelines for the other institutions, taking into account the specificities of the EEAS and the Court of Justice.

Mr VAUGHAN (S&D, UK) supported Ms HOHLMEIER and wanted her to point out that some progress had been made and that it was important to continue.

Mr ASHWORTH (ECR, UK) pointed out the contradiction between the lower cost of the EP compared with other parliaments and the increased responsibilities given to the EP by the Lisbon Treaty. He considered the lack of resources as worrying.

- Exchange of views

Mr FÄRM (S&D, SE) presented the rapporteur's first conclusions. Ms HERCZOG supported the Commission's proposal and considered it essential, due to the crucial role of the European political parties and foundations. She insisted on the need for a control of the respect of EU values and for financial flexibility, notably regarding the calendar of political activities, and she requested the possibility of carrying over appropriations. She considered that the organisation of joint events should not be considered as donations and that no limit should be defined on donations accepted by European political parties and foundations from natural or legal persons. She welcomed the creation of a committee to control the criteria to be respected by European political parties and foundations and requested that this committee should give its opinion within a reasonable time period. She wanted to highlight that national authorities also had an important role in the control over the funding of parties and foundations.

Mr LAMASSOURE underlined that this issue was sensitive as Member States had various cultural and historical backgrounds, going from absence of control to strict control, and various financing systems, going from public financing to financing only by members. He announced that Ms GRÄSSLE would be the rapporteur for the proposal amending the Financial Regulation in relation to this proposal.

Ms GRÄSSLE agreed with Mr LAMASSOURE's analysis. She supported the Commission's proposal in general but wanted to be cautious when creating exemptions compared with general rules and considered that those exemptions should be duly justified.
