Subject: Proposal for transfer of appropriations No DEC 56/2012 within Section III -

Commission - of the general budget for 2012

1. On 8 January 2013, the Commission submitted to the Council proposal for transfer of appropriations No DEC 56/2012.

The purpose of this proposal is to transfer a total amount of EUR 290 918 775 in payment appropriations from budget lines under:


- sub-heading 1a (Competitiveness for growth and employment): EUR 66.9 million;
- heading 2 (*Preservation and management of natural resources*): EUR 20.1 million;
- sub-heading 3a (*Freedom, security and justice*): EUR 4.1 million;
- sub-heading 3b (*Citizenship*): EUR 5.3 million;
- heading 4 (*The EU as a global player*): EUR 194.3 million; and
- heading 5 (*Administration*): EUR 0.3 million,

to the following budget lines under sub-heading 1b (Cohesion for growth and employment):

- Article 04 02 01 (Completion of the European Social Fund (ESF) Objective 1 (2000 to 2006)): EUR 79 646 434;
- Article 13 03 01 (Completion of European Regional Development Fund (ERDF) Objective 1 (2000 to 2006)): EUR 185 311 683; and
- Article 13 03 04 (Completion of European Regional Development Fund (ERDF) Objective 2 (2000 to 2006)): EUR 25 960 658,

as recorded in document 5053/13 FIN 5.

- 2. In accordance with Article 179(2) and (3) of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union¹, this "End of Year Transfer" intends to ensure that the outstanding requests for additional payments related to Structural Funds can be met, using any payment appropriations available at mid-December.
- 3. <u>The Budget Committee</u> examined this proposal for a transfer at its meeting on 9 January 2013.
- 4. Following that examination, <u>the Budget Committee</u> agreed, by qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in ANNEX to that effect.
