Statement by France

"La délégation française salue la tenue du 10^e Conseil d'Association entre l'Union européenne et la Jordanie. Elle saisit cette occasion pour rappeler son attachement à ce que les Etats membres soient étroitement et pleinement associés à la prise de décision sur toutes les problématiques relevant de la compétence du COREPER II, à commencer par celles relatives à la mobilité. Elle regrette que cela n'ait pas totalement été le cas s'agissant du relevé de conclusions de la Task Force avec la Jordanie le 22 février dernier et réitère donc la demande qu'elle avait présentée avec d'autres délégations à ce qu'un débat se tienne sur ce point, dans les meilleurs délais, au niveau du groupe Maghreb-Machrek afin de s'assurer du respect des procédures et des enceintes agréées."

Statement by the United Kingdom, the Netherlands, Austria and Portugal

"The United Kingdom, the Netherlands, Austria and Portugal welcome the Commission's intention to keep the Council informed of Iceland's progress in reconsidering a number of requests for technical adaptations, derogations and transitional periods. Specifically, we expect Iceland to bring its whaling policy in line with that of the EU by the date of accession and agree that Iceland should be invited to reconsider its request to amend Annexes IV and V of the Habitats Directive.

We recognise that whaling is a sensitive issue for Iceland, acknowledge Iceland's conservation efforts in the framework of other international agreements, and hope that Iceland will be able to fully support global efforts for cetacean conservation. We also note the considerable economic, social and educational benefits of Iceland's growing whale watching industry as an alternative to commercial whaling.

We note that this chapter may only be provisionally closed once an agreement has been reached on Iceland's special requests. We expect that Iceland will commit to take three specific steps by the date of accession to bring its whaling policy in line with that of the EU:

- 1. Fully align with the Habitats Directive, which is clear that all whale species are strictly protected within EU waters.
- 2. Remove any reservations to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES).
- 3. Fully align with the EU's common position in the International Whaling Commission (IWC) in support of maintaining the moratorium on commercial whaling."

Statement by Spain

"Spain considers that during the negotiations of chapter 27, "Environment", Iceland must proceed to harmonise its whale protection policy with the policy and *acquis* of the European Union."

"The Conclusions on a Swiss financial contribution for Croatia constitute a political decision under Article 16 of the Treaty on European Union. Article 16 confers policy-making powers to the Council. As a consequence, the Conclusions are to be understood as the political decision of the Council, not of the Member States.

Statement by Slovenia

"Slovenia shares from the very beginning the main objective of the Proposal for a Regulation of the European Parliament and of the Council on the European System of National and Regional Accounts in the European Union (ESA 2010). Large majority of concerns that Slovenia expressed towards the Commission's proposal was addressed during procedure so far. The compromise is thus almost fully satisfactory for Slovenia.

However, according to the current Regulation (Regulation ESA 1995, Regulation No 2223/1996) Slovenia has so-called permanent derogations for the transmission of the following statistics: GDP by the output approach at current prices, quarterly, for years 1995-1999; employment in hours worked, for years 1995-1999; financial accounts, for years 1995-2001; government expenditure by function, for years 1995-1999. Slovenia will do its best to compile the missing statistics and fill the gaps but this will not be possible for all mentioned data. This relates in particular to financial accounts and government expenditure by function. Data sources needed to compile mentioned statistics are not available and they cannot be created for the past. Consequently, Slovenia will never be in a position to compile these statistics and to comply with requirements of the Regulation. Therefore, we cannot support the compromise text."

Statement by Sweden

"Sweden believes in the importance to apply the principles enshrined in the UN Agreement on Migratory Stocks and in the International Guidelines for Deep Sea Fishing from 2008, particularly concerning the stock assessments, impact assessments and the application of the precautionary approach. During the deliberations, Hungary has actively contributed to the text with significant proposals.

However, as regards certain provisions in the text proposal put on the agenda of the Council by the Presidency concerning the content of bilateral agreements with third countries, notably in Annex VI, Hungary has concerns as regards the revision of existing bilateral agreements; which can have a negative effect on already ongoing cooperation with third countries in the course of border checks, based on recently concluded and finalized bilateral agreements."

Statement by Slovenia

"The Republic of Slovenia expresses its commitment to comprehensive implementation of the proposed changes of the Regulation (EC) No 562/2006 of the European Parliament and of the Council of 15 March 2006 establishing a Community Code on the rules governing the movement of persons across borders (Schengen Borders Code) and the Convention implementing the Schengen Agreement (the proposal 2011/0051 (COD)). However, at the same time it wishes to point out possible consequences of the changes to Article 21, paragraph d, of the Schengen Borders Code and Article 22 of the Convention.

The existing obligation for third-country nationals to register their presence to the competent authorities of a member state presents a crucial connection between a third country national and a member state. The amendment of the articles mentioned above transforms this obligation into a possibility of a member state to regulate this issue in its national legislation. We believe that non-harmonised rules in member states could have an unfavourable effect on the management of legal and irregular migration and consequently on the level of internal security in member states and in the Union "
