## 1. SIS II

- State of play

<u>The Commission</u> gave an overview of the state of play. Regarding the situation in FI, the Commission explained that an alternative solution had been proposed to FI that could avoid a delay of the entry into operations. FI confirmed the information and stated that a decision on the issue would be taken in the near future.

## 2. Schengen governance

- The situation in the Schengen area Second biannual report from the Commission to the European Parliament and the Council on the functioning of the Schengen area (1 May - 31 October 2012)

<u>The Commission</u> presented its second biannual report which was followed by an exchange of views during which the Council expressed its general satisfaction concerning Schengen cooperation. <u>The</u> <u>Council</u> also took note of the clarifications provided by the Presidency and the Commission on the

issue of the flanking measures undertaken by Romania and Bulgaria, including in particular the view expressed by the Presidency that, on the basis of the report it had made in October, the progress made by these two countries on the implementation of the flanking measures to date was such as to enable it to regard the process as now completed.

<u>Ministers</u> took note of the outcome of the discussion held in CATS on obstacles related to effective information exchange. The Presidency invited Member States to ensure the implementation of the relevant legislation.

- the JHA related proposals under the Multiannual Financial Framework 2014-2020;
- the draft Regulation amending the Schengen Borders Code (technical amendments).
