Subject Budget for SISNET for the year 2013

1. The Financial Regulation as established by Council Decision 2000/265/EC of 27 March 2000 on the establishment of a financial regulation governing the budgetary aspects of the management by the Deputy Secretary-General of the Council, of contracts concluded in his name, on behalf of certain Member States, relating to the installation and the functioning of the communication infrastructure for the Schengen environment, 'SISNET'<sup>1</sup>, as subsequently amended by Council Decision 2000/664/EC of 23 October 2000<sup>2</sup>, Council Decision 2003/171/EC of 27 February 2003<sup>3</sup>, Council Decision 2007/155/EC of 5 March 2007<sup>4</sup>, Council Decision 2008/319/EC of 14 April 2008<sup>5</sup>, Council Decision 2008/670/JHA<sup>6</sup> of 24 July 2008 and Council Decision 2009/915/EC of 30 November 2009<sup>7</sup> provides in its Article 8 that the Member States referred to in Article 25 of that Financial Regulation, meeting within the Council, shall adopt the budget, once the SIS/SIRENE Working Party has delivered its opinion on the preliminary draft budget.

- 2. In its meeting of 20 December 2012, the Working Party for Schengen Matters (SIS/SIRENE) has delivered a favourable opinion on the preliminary draft budget, as set out in document 17447/12 SIRIS 114 COMIX 721.
- 3. On this basis, COREPER is invited to submit the budget for SISNET, as set out in annex, for adoption to the Member States referred to in Article 25 of the abovementioned Financial Regulation.
- 4. The contributions from the concerned Member States and Iceland, Norway, Switzerland and Liechtenstein shall be calculated according to the distribution key laid down in Article 26 of the abovementioned Financial Regulation.
- 5. The Secretary-General shall notify the decision to adopt the budget to the States referred to in Article 25 of the above-mentioned Financial Regulation.
