Subject: Governing Board of the European Foundation for the Improvement of Living and Working Conditions
Appointment of Ms Charlotte HOUGAARD MØLLER, Danish alternate member, in place of Mr Nils Juhl ANDREASEN, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Mr Nils Juhl ANDREASEN as alternate member of the Governing Board of the above Foundation in the employers' representatives category (for Denmark).
2. Under Article 6 of Regulation (EEC) No 1365/75, as amended by Regulation (EC) No 1111/2005, members and alternate members of the Governing Board are appointed by the Council.

3. In accordance with the usual procedure, the employers' organisation BUSINESSEUROPE has nominated the following candidate to replace the resigning alternate member for the remainder of the current term of office, ending on 30 November 2013:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EEC) No 1365/75 of 26 May 1975 on the creation of a European Foundation for the Improvement of Living and Working Conditions¹, and in particular Article 6 thereof,

Whereas:

- (1) In its Decisions of 22 November 2010², 7 March 2011³, 12 July 2011⁴ and 20 September 2011⁵ the Council appointed the members and alternate members of the Governing Board of the European Foundation for the Improvement of Living and Working Conditions for the period ending on 30 November 2013.
- (2) A seat as alternate member of the Governing Board of that Foundation in the employers' representatives category has fallen vacant as a result of the resignation of Mr Nils Juhl ANDREASEN.
