Subject: Proposal for a Council Decision on the position on Decision No 1/2013 of the
Joint Veterinary Committee set up by the Agreement between the European
Community and the Swiss Confederation on trade in agricultural products
regarding the amendment of Appendices 1, 2, 3, 5, 6 and 10 to Annex 11 to the
Agreement
- Adoption

- 1. On 28 November 2012, the <u>Commission</u> submitted to the <u>Council</u> the above mentioned proposal.
- 2. The aim of the proposal is to determine the EU position for amending the Annex 11 of the Agreement between the European Community and the Swiss Confederation on trade in agricultural products ("veterinary agreement"). The proposal acknowledges an equivalency of Swiss legislation with certain recent changes in the EU legislation concerning animal byproducts and protection of animals at the time of slaughter, subject to special conditions. It also introduces a number of technical updates to the Agreement.

3. The proposal was examined by the <u>Working Party of Agricultural Counsellors / Attachés</u> on 7 December 2012 and by the <u>Working Party of Chief Veterinary Officers</u> on 19 December 2012 and on 23 January 2013¹. It found approval by all delegations at Working Party level.

Due to the late submission of the proposal, its adoption by the <u>Council</u> and the subsequent signature of the agreement before the end of 2012 was not possible. Following the advice of the Council Legal Service, the <u>Working Party</u> agreed that the text should be slightly revised to take into account the need for the retroactive application of the agreement as from 1.1.2013.

- 4. In view of the above, COREPER (1st Part) is invited
 - to confirm its approval of the draft Decision set out in document 16724/12², and
 - to request the <u>Council</u> to adopt by unanimity the above mentioned Decision as set out in document 16724/12.

This was followed by an information point at the Working Party on European Free Trade Association (EFTA) at its meeting of 24 January 2013.
