Subject:	Discharge to be given to the executive agencies in respect of the implementation of the budget for the financial year 2011			
	- Draft Council recommendations			

- 1. In accordance with Council Regulation (EC) No 58/2003 of 19 December 2002 laying down the statute for executive agencies to be entrusted with certain tasks in the management of Community programmes¹, and in particular Article 14(3) thereof, and Commission Regulation (EC) No 1653/2004 of 21 September 2004 on a standard financial regulation for the executive agencies pursuant to Council Regulation (EC) No 58/2003², as last amended by Commission Regulation (EC) No 651/2008 of 9 July 2008³, and in particular Article 66, first paragraph, thereof, the Council is required to draw up recommendations to the European Parliament on a discharge to be given to the executive agencies.
- 2. At its meetings on 15, 21 and 23 January 2013, the <u>Budget Committee</u> examined the six specific annual reports⁴ of the European Court of Auditors related to executive agencies, and reached an agreement on the draft texts as set out in the Addendum.
