The 57th session of the United Nations Commission on the Status of Women will be held in New York on 4-15 March 2013.

The session's priority theme is "elimination and prevention of all forms of violence against women and girls", which is also one of the longstanding priorities of the European Parliament's Committee on Women's Rights and Gender Equality.

As part of the established practice, the names of the other Members will be forwarded by email by Parliament's Secretariat to its Council counterpart at least two weeks before the meeting.
