Remaining reservations (RO) and scrutiny reservations (DE and SE) were withdrawn.

The Chair informed the Committee about the main points discussed at the second trilogue on 29 January 2013, namely EMSA, the MODUS codes, global standards and reporting obligations, addressees in relation with landlocked countries, competent authority for which the EP appears to support the principle of a threshold to decide when to apply functional separation, liability and the issue of economic damage for which a solution seems to be within reach, public participation for which the still bracketed text in the Council position would be acceptable to the EP, recital 40 on the Arctic where the EP demands cannot be accommodated, and a few other more technical issues.

The Commission's main concern is in relation with competent authority, where it does not see the Council text nor the EP one achieving the degree of independence required.

The next trilogue is scheduled on 21 February 2013.

38. Debrief on the VI EU-Brazil Summit

<u>The Committee</u> was debriefed, by the <u>EEAS</u> and the <u>Commission</u>, on the outcome of the EU-Brazil Summit held in Brasilia, on 24 January 2013.

The Summit had signalled the willingness to further strengthen the Strategic Partnership and confirmed the good potential for joint collaboration, on areas such as science, technology and innovation, education, climate change, sustainable development but also human rights, or UN matters. The decision to establish a new dialogue on international peace and security matters could ultimately lead to the signature of a Framework Participation Agreement to CSDP missions.

The main emphasis had been on economic relations and how to enhance competitiveness. It had been agreed to establish an ad-hoc Working Group that should analyse more systematically bilateral economic issues, including investment, competitiveness and trade. The EU side had voiced strong concern for the protectionist measures adopted by the Brazilian government to protect its industrial sector.

On the bi-regional side, Brazil had stressed its unreserved commitment to the EU-Mercosur Association Agreement; however, it had indicated that progress would possible only and exclusively with the full commitment and involvement of the other Mercosur members.
