- 1. On 4 May 2012 the <u>Commission</u> submitted to the Council the above proposal.
- 2. This proposal aims at adapting Council Decision 97/836/EC to the decision making procedures set out in the Treaty on the Functioning of the European Union regarding international agreements concluded by the EU.

- 3. The <u>Working Party on Technical Harmonisation (Motor Vehicles)</u> examined this proposal on three occasions, on 12 July, 18 September and 17 December 2012. At this last meeting the Working Party unanimously agreed on the text as set out in the Annex.
- 4. The <u>Permanent Representatives Committee</u> is invited therefore :
  - to confirm the agreement reached by the Working Party,
  - to suggest that the Council decides, in part "A" of its agenda at a forthcoming meeting, to forward the text of this Decision, as set out in document 5978/13following its finalisation by the legal-linguists, to the European Parliament for its consent.

# Proposal for a **COUNCIL DECISION**

amending Decision 97/836/EC with a view to accession by the European Community to the Agreement of the United Nations Economic Commission for Europe concerning the adoption of uniform technical prescriptions for wheeled vehicles, equipment and parts which can be fitted to and/or be used on wheeled vehicles and the conditions for reciprocal recognition of approvals granted on the basis of these prescriptions ('Revised 1958 Agreement')

### THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 207(34) and thereof, in conjunction with Article 218(6)(a)(v)-thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament<sup>1</sup>,

Whereas:

(1) By Council Decision 97/836/EC<sup>2</sup>, the Union has acceded to the Agreement of the United Nations Economic Commission for Europe concerning the adoption of uniform technical prescriptions for wheeled vehicles, equipment and parts which can be fitted to and/or be used on wheeled vehicles and the conditions for reciprocal recognition of approvals granted on the basis of these prescriptions ('Revised 1958 Agreement').

- (1a)Directive 2007/46/EC of the European Parliament and of the Council of 5 September2007 establishing a framework for the approval of motor vehicles and their trailers,<br/>and of systems, components and separate technical units intended for such vehicles<br/>(Framework Directive) <sup>1</sup> replaced the Member States' approval systems with a Union<br/>approval procedure, establishing a harmonised framework containing the<br/>administrative provisions and general technical requirements for all new vehicles,<br/>systems, components and separate technical units. That Directive incorporated<br/>UNECE Regulations in the EU vehicle type-approval system, either as requirements<br/>for type-approval or as alternatives to EU legislation. Since the adoption of Directive<br/>2007/46/EC, UNECE Regulations have increasingly been incorporated in EU<br/>legislation in the framework of EU vehicle type-approval.
- (2) The e<u>C</u>hanges to the Treaties and in particular on which the Union is founded occurred after the adoption of <u>Decision 97/836/EC.</u> <u>\*</u>The Treaty on the Functioning of the European Union have <u>has</u> substantially altered the decision-making procedure to be followed for the conclusion of agreements between the Union and international organisations, making it necessary to adapt Decision 97/836/EC to the new procedures.
- (3) The procedure for establishing the position to be adopted on the Union's behalf in the United Nations concerning the adoption of UNECE Regulations or amendments to UNECE Regulations should <del>also</del> be adapted to the new procedures <del>under the Treaty and, therefore,</del> should be subject to <u>set out in</u> Article 218(9) of the Treaty <u>on the Functioning of the</u> <u>European Union.</u>
- (4) The same procedure should also be followed when the Union decides to apply UNECE
   Regulations to which it has not acceded at the time of its accession to the Revised
   Agreement or to cease to apply a UNECE Regulation that it has previously accepted.

- (5) It is appropriate that the procedure for adopting proposed amendments to the Revised Agreement submitted by the Union, as well as the decision whether to raise an objection to the <u>a</u> proposed amendment<u>s</u> is <u>be</u> the same as the procedure for the accession to international agreements.
- (6) Decision 97/836/EC should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

#### Article 1

Decision 97/836/EC is <u>hereby</u> amended as follows:

## (1) **Paragraphs 2 and 3** of Article 3 is amended as follows are replaced by the following:

(a) Paragraph 2 is replaced by the following:

"2. Pursuant to Article 1(6) of the Revised 1958 Agreement, the Union may, in accordance with the procedure laid down in Article 4(2) of this Decision 218(9) of the Treaty on the Functioning of the European Union (TFEU), decide to cease to apply a UNECE Regulation that it has previously accepted."

#### (b) Paragraph 3 is replaced by the following:

"3. Pursuant to Article 1(7) of the Revised 1958 Agreement, the Union may, in accordance with the procedure laid down in Article 4(2) of this Decision 218(9) <u>TFEU</u>, decide to apply one, some or all of the UNECE Regulations to which it has not acceded at the time of its accession to the Revised 1958 Agreement."

- (2) Article 4 is <u>hereby</u> amended as follows:
  - (a) Paragraph 2 is replaced by the following:

"2. The Union shall vote in favour of adopting any draft UNECE Regulation or a draft amendment to a <u>UNECE</u> Regulation where the draft has been approved in accordance with the procedure set out in Article 218(9) of the Treaty <u>TFEU</u>."

# (b) Paragraph 4 is deleted. <u>References to Article 4(4) in Directive 2007/46/EC and</u> <u>Regulation (EC) No 661/2009 shall be construed as references to Article 4(2).</u>

(3) Article 5 is replaced by the following:

#### "Article 5

- The proposed amendments to the Revised 1958 Agreement submitted to the Contracting Parties on behalf of the Union shall be adopted in accordance with the procedure set out in Article 218(6)(a) of the Treaty <u>TFEU</u>.
- The decision whether <u>or not</u> to raise an objection, or otherwise, to the <u>a</u> proposed amendments to the Revised 1958 Agreement put forward by <u>an</u>other Contracting Part<u>yies</u> shall be taken in accordance with the procedure set out in Article 218(6)(a) of the Treaty <u>TFEU</u>.

Where that procedure has not been completed a week before expiry of the deadline provided for in Article 13(2) of the Revised 1958 Agreement, the Commission <u>Union</u> shall state an objection to the amendment<del>, on behalf of the Union, before that deadline expires."</del>

- (4) Annex III is <u>hereby</u> amended as follows:
  - (a) Point 1 is amended as follows:
    - (i) The first paragraph is replaced by the following:

"The contribution of the Union with regard to the priorities of the work program<u>me</u> shall be established as appropriate in accordance with the procedure laid down in Articles 218(3) and (4) of the Treaty <u>TFEU</u> in conjunction with Article 207(2) of the Treaty <u>TFEU</u>."

(ii) In the third paragraph, the first sentence is replaced by the following:

"Following this preparatory phase, the Commission shall represent the Union in the Administrative Committee as set up by Article 1 of the Revised 1958 Agreement as spokesman for the Union, in conformity with Article 207 of the Treaty <u>TFEU</u>."

(b) In point 2, the second sentence of the second paragraph is replaced by the following:

"For this purpose the Commission shall submit its proposal as soon as all of the essential components of the draft UNECE Regulation have been supplied."

#### Article 2

This Decision shall enter into force on the third day following <u>that of</u> its publication in the *Official Journal of the European Union*.

#### Article 3

This Decision shall be notified by the Commission to the Secretary-General of the United Nations.
