Whereas:

- (1) In its Decisions of 21 October 2010<sup>4</sup> and 7 March 2011<sup>5</sup>, the Council appointed the members and alternate members of the Advisory Committee for the Coordination of Social Security Systems for the period ending on 19 October 2015.
- (2) A seat as member in the employers' representatives category has fallen vacant as a result of the resignation of Ms Pilar IGLESIAS VALCARCE.
