Subject:	Working methods of the CVO Working Party

Delegations will find attached <u>a Presidency note</u> in preparation of the discussion on the working methods of the CVO Working Party.

In follow-up to the January meeting, the Presidency would like to come back on the working methods of the CVO Working Party.

In addition to the discussion of strategic matters in the veterinary field, the Coreper mandate for the Working Party (see doc 16069/03) defines the following main axes of activity:

- 1. and 2. general guidelines before and examination of key technical elements after work done by technical working parties;
- 3. cooperation in the drafting of the work programme;
- 4. key questions to bi- and multilateral discussions with third countries.

The CVO WP has fulfilled its broad mandate along all these axes:

- as to its contribution to general policy questions, see the list attached in the Annex;
- direct input to technical working parties was regularly given for important files such as the
  Hygiene package, avian influenza or more recently legislation on maximum residue levels of
  veterinary drugs, Bluetongue and EID;
- the work programme is discussed at the beginning of each Presidency and frequently completed via AOB points introduced by individual delegations and subsequently taken up as formal discussion items (such as African swine fever, private standards or the present agenda item);
- the establishment of EU positions in multilateral organisations in particular OIE and in third country relations are a regular item on the agenda (as to the interplay between CVOs and the Potsdam WP, see doc. 9605/08 ADD 1 REV 1).

In addition, the CVO WP has been successfully used in the past as a forum for presentation of the various approaches chosen by individual Member States' to specific policy questions, such as assistance to third countries in the veterinary field or cost and responsibility sharing systems.

Specific seminar-like discussions on topics of general interest, based on presentations by experts, have been a frequent feature in particular at the occasion of out-of-Brussels CVO meetings, sometimes leading to formal CVO conclusions as a follow-up.

Particularly in view of the huge amount of legislative work in the pipeline and experience gained in the handling of third country relations, the Presidency deems it very appropriate to take up the suggestion made by members of the WP and launch a discussion on how to make best use of CVOs' contribution to Council's work.

In order to structure the debate, the Presidency would ask CVOs to reflect upon the following questions:

- Are there questions of general policy which would merit particular attention by CVOs outside the range of legislative proposals soon to be presented (Animal Health package, zootechnics, Hygiene package revision, cloning, veterinary medicine)?
- For such topics, should more systematic recourse be taken to seminar-like discussions based on introductory presentations?
- In the context of expected legislative proposals on animal health / official controls / expenditure in the veterinary field, which questions of over-arching importance might be particularly appropriate for definition of general guidelines by CVOs?
- Are there topics of general interest which would call for a series of presentations by individual delegations, followed by joint debate?
- Should the preparation of EU positions in third country relations in the veterinary field, and in particular the workflow between CVOs and the Potsdam WP, be re-examined?
