The SCA took note of the comments by the Commission and the Council Legal Service representatives as well as by the Bulgarian, Danish, German, Greek, French, Italian, Cypriot, Luxembourg, Hungarian, Maltese, Austrian, Polish, Portuguese, Romanian, Slovenian, Slovak, Finnish and UK delegations. The Presidency concluded that a large number of delegations supported the text.

The SCA took note of delegations' views on the Presidency suggested amendments aimed at further simplifying the operation of the Small Farmers Scheme (doc. 6375/13), of the scrutiny reserves entered and of the comments made by the Commission representative.

- = the Presidency's intention to reflect on the outcome of the discussion.
