**Government decision**

Pursuant to Article 305 of the Treaty on the Functioning of the European Union, the Swedish Government has decided to nominate Tore Hult (S) and Ulrika Carlefall Landergren (FP) as new members and Anders Rosén (S) as a new alternate member of the Committee of the Regions of the European Union for the period ending on 25 January 2015.

**Background**

Anneli Stark (S) and Tore Hult (S) have resigned from their posts as member and alternate member of the Committee of the Regions of the European Union respectively. On 10 January 2013, the Swedish Association of Local Authorities and Regions (SALAR) wrote to the Swedish Government proposing the nomination of Tore Hult (S) as a new member in place of Anneli Stark (S) and Anders Rosén (S) as a new alternate member in place of Tore Hult.

In a decision issued on 18 January 2013, SALAR nominated Ulrika Carlefall Landergren (FP) as a new member in place of the late Britt-Marie Lövgren (FP).
