Pursuant with Article 55(3) of Regulation (EC) No 1987/2006 and Article 71(3) of Decision 2007/533/JHA, the Commission stated that:

 the Commission Implementing Decision adopting the SIRENE Manual and other implementing measures for the second generation Schengen Information System (SIS II) was adopted on 27 February 2013;

- all the Member States fully participating in the SIS 1+ have notified the Commission that they have made the necessary technical and legal arrangements to process SIS II data and exchange of supplementary information; and
- <u>the Commission</u> has made the necessary technical arrangements for allowing Central SIS II to be connected to N.SIS II of the Member States concerned.

<u>The Committee</u> confirmed 9 April 2013 as the date for entry into application of Regulation (EC) No 1987/2006 and Decision 2007/533/JHA and agreed on the draft Council Decisions as set out in docs. 6840/13 and 6841/13 being submitted to the Council (JHA) on 7 March 2013 for adoption.

DE stated that it will abstain from voting for the reasons set out in doc. 6937/13.
