<u>The Committee</u> discussed the outstanding issues for finalizing the general approach. The Council Legal Service took the floor to inform about its views on Article 16(1).

It stressed that Article 16(1), insofar as it reproduces the formulation of the principle of relative stability, could be regarded as a specific measure on the allocation of fishing opportunities, hence falling within the Council's prerogatives under Article 43(3) TFEU rather than within the legislator powers under Article 43(2) TFEU.

The Chairman concluded that Article 5 (definitions) has been agreed, and that changes to Articles 12, 15 and 16 should be further discussed at Council. The item is retained on the Council's agenda.

The Executive Secretary General of the EEAS informed <u>the Committee</u> of the way in which the High Representative intends to conduct the exchange of views at the Foreign Affairs Council on 11 March 2013.

The Council is expected to start at 9H30.

The main items foreseen for discussion, at the stage, are: Russia, Southern Neighbourhood, and Japan.

<u>The Committee</u> had a preliminary discussion in relation to the preparations and priorities for the next EU-Japan Summit on the basis of document 6498/13 RESTREINT UE. The debate provided input for further preparations in the relevant preparatory bodies of the Council as regards the content of the Summit agenda and its joint statement.

<u>The Committee</u> noted a high level of agreement for the broadening and strengthening of the EU-Japan relationship, including through the launch of negotiations for a Framework Agreement and a Free Trade Agreement with Japan.

The Committee decided to revert to the issue in late March.

51. Preparation of the EU-Ukraine Summit

<u>The Committee</u> had an exchange of views on preparations for the EU-Ukraine Summit (Brussels, 25 February 2013) on the basis of an oral presentation by the European External Action Service. Delegations expressed broad support for the approach proposed and emphasised the tight timetable for Ukraine to make tangible progress in fulfilling the conditions for signing the Association Agreement, including DCFTA, by or at the Vilnius European Partnership Summit in November 2013, but also for the EU to complete the necessary technical procedures.
