(application EGF/2011/016 IT/Agile from Italy)

1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 7291/13 FIN 123 SOC 160, accompanied by the corresponding proposal for transfer of appropriations No DEC03/2013, as recorded in document 7292/13 FIN 124.

2. The proposal aims at mobilising an amount of EUR 3 689 474 under the EGF to meet an application from Italy to deploy the Fund in connection with redundancies in Agile S.r.l, a company operating in the Information and Communication Technology sector. The Italian IT services provider suffered from significant losses leading to its insolvency due to a downturn in the ICT market, as a consequence of a global financial and economic crisis.

The purpose of the proposed transfer is to move an amount of EUR 3 689 474 in commitment appropriations from Article 40 02 43 (Reserve for the European Globalisation Adjustment *Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*).

- 3. At the simplified trilogue procedure provided for in Point 28 of the Interinstitutional Agreement of 17 May 2006, an agreement was reached on the mobilisation of the EGF and on the amount proposed by the Commission.
- 4. The <u>Budget Committee</u> examined both proposals at its meeting on 26 Mars 2013.
- 5. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the proposed Decision on the mobilisation of the EGF;
 - approve the proposed transfer of appropriations;
 - approve the draft letter in the ANNEX to that effect.
