Proposal for transfer of appropriations No DEC 02/2013 within Section III -

1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 6985/13 FIN 105 SOC 141, accompanied by the corresponding proposal for transfer of appropriations No DEC 02/2013, as recorded in document 6986/13 FIN 106.

The proposal aims at mobilising an amount of EUR 5 037 482 under the EGF to meet an application from Italy to deploy the Fund in connection with redundancies in the sector of domestic appliances. The Italian producer of domestic appliances suffered from a significant downturn in its production due to a drop in the domestic and European demand and growing competition from China and Turkey, as a consequence of a global financial and economic crisis.

The purpose of the proposed transfer is to move an amount of EUR 5 037 482 in commitment appropriations from Article 40 02 43 (*Reserve for the European Globalisation Adjustment Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*).

- 3. At the simplified trilogue procedure provided for in Point 28 of the Interinstitutional Agreement of 17 May 2006, an agreement was reached on the mobilisation of the EGF and on the amount proposed by the Commission.
- 4. The <u>Budget Committee</u> examined both proposals at its meeting on 12 March 2013.
- 5. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the proposed Decision on the mobilisation of the EGF;
 - approve the proposed transfer of appropriations;
 - approve the draft letter in the ANNEX to that effect.
