- 1. The <u>European Commission</u> submitted the above proposals to the Council on 1 June 2012.
- 2. These proposals follow the <u>Council</u>'s decision of 10 December 2010 to authorise the Commission to open negotiations with the Swiss Confederation concerning cooperation on the application of their competition laws.

- 3. On 2 July 2012, the <u>Working Party on Competition</u> reached an agreement on the proposals subject to lifting the scrutiny reservations entered by <u>DE, IE, FR and UK delegations</u>. Subsequently, these delegations have lifted their scrutiny reservations.
- 4. The texts have been finalised by legal-linguistic experts.
- 5. Consequently, the <u>Permanent Representatives Committee</u> is invited to confirm the agreement reached by the Working Party and to suggest that the <u>Council</u>, at one of its forthcoming meetings,
 - (a) <u>decides</u> on the signature, on behalf of the European Union, of the Agreement between the European Union and the Swiss Confederation concerning cooperation on the application of their competition laws as set out in doc. 12416/12 RC 20 CH 28 AELE 55 OC 401 and 12513/12 RC 22 CH 30 AELE 58 OC 413; and
 - (b) requests the consent of the European Parliament on the text of the Agreement between the European Union and the Swiss Confederation concerning cooperation on the application of their competition laws as set out in doc. 12513/12 with a view to the adoption of the Council Decision on the conclusion of the Agreement (doc. 12418/12 RC 21 CH 29 AELE 56 OC 402).
