<u>The delegations</u> provided <u>the Presidency</u> with an updated mandate on outstanding issues as set in document 7436/13.

<u>DK, NL, AT and UK</u> raised concerns about Article 4(1) concerning public access to risk assessment.

<u>DK</u> was of the view public access to documents should be addressed rather in a horizontal directive. <u>NL, AT and UK</u> questioned the appropriateness of the legal basis of the draft Directive for such a provision. In particular, <u>NL and AT</u> felt that the Directive should not contain a provision which does not contribute to the objective of protection of health and safety of workers as stipulated in Article 153(2) of TFEU.

<u>NL and AT</u> made the following statement to be entered into <u>the Committee</u> minutes :

"The Directive on Electromagnetic Fields (EMF) aims at protection of health and safety of workers against the effects of electromagnetic fields. For this purpose, the directive is based on Article 153(2) TFEU, which provides a legal basis for directives laying down minimum requirements in the field of protection of health and safety of employees at the workplace. There is no objective evidence that Article 4(1) of the directive on EMF defining the employer's obligation to make risk assessments public on request contributes to the objective of protection of health and safety of workers. Therefore, Article 4(1) does not serve the purpose of Article 153(2) TFEU.

To this end, the directive should not contain the provision in Article 4(1)."

<u>UK</u> entered a scrutiny reservation on Article 4(1). <u>BG</u> lifted a scrutiny reservation on this provision.

While being aware of the concerns of a few delegations about the acceleration of the pace of negotiations and the need for more internal consultations the Chair noted that most delegations were willing to see these negotiations being concluded and could agree to the compromise package proposed around Art. 4 and 6. Regarding Art. 6 its provisions should meet the concerns of Member States while not being open to abuse. Regarding deadlines 24 months for transposition and 36 months for reporting (Art. 13) should be retained.

<u>The Committee</u> agreed on the mandate for the 3rd informal trilogue to be held on 25 March 2013 on the basis of the position set out in 7493/13 as amended regarding the reporting period.

<u>The Committee</u> confirmed agreement for an amended mandate to the Presidency, on the basis of a compromise set out in document 7476/13, with a view to engaging in the fourth informal trilogue to be held on 21 March 2013.

<u>NL</u> made the following statement :

"The Netherlands is in favour of the EURODAC proposal and creating the possibility to use EURODAC data under strict conditions for criminal investigations into serious crimes.

There is however a critical opinion of the European Data Protection Supervisor.

The criticism focuses on the necessity and proportionality to compare dactyloscopic traces from a crime scene or fingerprints of suspects of serious crimes with those of asylum seekers.

The Netherlands differs of opinion with the European Data Protection Supervisor. Since 1989, fingerprints of suspects or dactyloscopic traces from crime scenes may under strict conditions be compared with those of asylum seekers in the national files in the Netherlands. The percentage of hits in the Netherlands confirms that this legal competence is necessary for the investigation of serious criminal offences.

In the Dutch Parliament there are concerns about this proposal and, in particular, there is concern about the risk of indirect discrimination.

A monitoring and evaluation mechanism is provided for in the EURODAC proposal.

The evaluation will assess if the consultation of EURODAC for the prevention, detection and investigation of terrorist offences and other serious criminal offences has led to indirect discrimination of persons seeking international protection.

The Netherlands attaches great importance to this element of the evaluation.

The Netherlands would like to ask the European Commission to pay its attention to this aspect of the evaluation from the moment the Regulation will entry into force.

If it is necessary to collect certain data to determine possible stigmatizing effects, the relevant authorities should be informed in time."

Presidency informed on delegated/implementing acts, as in Coreper Part 2, 20 March 2013, regarding recent contacts between the Commission and the Council, and between the three institutions, to find a way forward on this topic. The Antici Group will work on the issue after Easter.
