THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 338(1), in conjunction with Article 218(9) thereof,

Having regard to Council Regulation (EC) No 2894/94 of 28 November 1994 concerning arrangements for implementing the Agreement on the European Economic Area¹, and in particular Article 1(3) thereof,

Having regard to the proposal from the European Commission,

Whereas:

- (1) The Agreement on the European Economic Area¹ ("the EEA Agreement") entered into force on 1 January 1994.
- (2) Pursuant to Article 98 of the EEA Agreement, the EEA Joint Committee may decide to amend, inter alia, Annex XXI thereto.
- (3) Annex XXI to the EEA Agreement contains specific provisions and arrangements concerning Statistics.
- (4) Commission Regulation (EU) No 555/2012 of 22 June 2012 amending Regulation (EC) No 184/2005 of the European Parliament and of the Council on Community statistics concerning balance of payments, international trade in services and foreign direct investment, as regards the update of data requirements and definitions² should be incorporated in the EEA Agreement, with certain adaptations for Norway, Iceland and Liechtenstein.
- (5) Annex XXI to the EEA Agreement should therefore be amended accordingly.
- (6) The position of the Union in the EEA Joint Committee should be based on the attached draft Decision,

- (2) Annex XXI to the EEA Agreement should therefore be amended accordingly,

Article 1

Point 19s (Regulation (EC) No 184/2005 of the European Parliament and of the Council) of Annex XXI to the EEA Agreement shall be amended as follows:

- 1. The following indent is added:
 - **'**_ **32012 R 0555**: Commission Regulation (EU) No 555/2012 of 22 June 2012 (OJ L 166, 27.6.2012, p. 22).'
- 2. The text of the adaptation is replaced by the following:
 - '(a) Points 1 and 2 of Table 1 of Annex I shall not apply to Norway.
 - Table 1 of Annex I shall not apply to Iceland before May 2017. (b)
 - (c) This Regulation shall not apply to Liechtenstein.'.

Article 2

The texts of Regulation (EU) No 555/2012 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the Official Journal of the European Union, shall be authentic.
