# 1. Adoption of the agenda

The agenda as set out in CM 2404/13 was adopted with the addition of one point under AOB.

# 2. Draft Council Conclusions on the Provision of Information on the Rights of Victims of Trafficking in Human Beings

Discussion

The Presidency had circulated a second revised version that most delegations could agree to, in particular leaving more flexibility to those delegations that had expressed concerns about the reference to one single document. Bearing in mind the the importance of keeping the access to information as easy as possible for victims, it was agreed to add a sentence on the desirability to compile information from different sources in a single dossier.

The Commission's publication on victims' rights will be attached as an appendix, and a one-year deadline for complying with the objective. A few other changes were made. The Presidency concluded that this agreed third revised draft would be submitted to COREPER on 15 May with a view to being adopted at the June JHA Council as a I/A-item.

# 3. Sixth round of mutual evaluations - Adoption of the Report of Estonia

The report was adopted.

DE, while agreeing to the report, reiterated that they could not adhere to Recommendation 6 of the report as the posting of a liaison officer in the Russian Federation required the prior conclusion of an agreement between Eurojust and that country, for which DE supported by NL would presently not grant the mandate due to the insufficient level of data protection.
