Statement by the Federal Republic of Germany

Proposal for a Regulation on food intended for infants and young children and on food for special medical purposes

"Germany is opposed to the current proposal for a Regulation on food intended for infants and young children and on food for special medical purposes.

Germany has always supported revision of the European legislation on dietetic foods in principle. The desired objectives of simpler and better regulation and more far-reaching harmonisation of this area of law are not, in Germany's view, adequately achieved by the proposed Regulation.

In particular, Germany considers that the new Regulation does not take adequate account of the special level of protection required for highly vulnerable target groups. The German view is that, for reasons of preventive health protection, it is problematic to allow the unrestricted addition of various substances added, because of their nutritional or physiological effect, to foodstuffs within the scope of the Regulation.

In this context, Germany observes inter alia an irreconcilable discrepancy between the stringent requirements of the Health Claims Regulation on the scientific verifiability of nutrition and health claims in food advertising on the one hand, and the clearly less stringent safety requirements with regard to preventive consumer health protection in relation to foods for special medical purposes on the other.

Furthermore, the proposed Regulation no longer contains the procedure for approving an extension of the positive list that was originally included, so that the addition of substances not hitherto covered in the positive list is now left to the sole initiative of the European Commission. Food producers are thereby deprived of the possibility of obtaining European approval for a substance by a clearly regulated procedure and thus securing legal certainty for innovations. The new Regulation consequently does not meet the requirement to promote innovation."

Statement by the United Kingdom

"The United Kingdom supports the aim to simplify the regulatory framework for foods for vulnerable groups and considers that the proposed text largely achieves this objective. However, the UK does not support the use of delegated acts to amend the Union list of substances and therefore is unable to support the proposal. Decisions on the authorisation of individual substances should be achieved by means of implementing acts using the examination procedure in Regulation (EU) 182/2011. The use of a delegated act in this particular circumstance must not be considered as a precedent for other areas of food policy."

Statement by Poland

"Throughout the negotiations Poland had been consistently pointing out that the proposal for a Decision of the European Parliament and of the Council derogating temporarily from Directive 2003/87/EC of the European Parliament and of the Council establishing a scheme for greenhouse gas emission allowance trading within the Community as presented by the European Commission provides only for a partial solution to the problem which has arisen in the application of the ETS in the aviation sector. Poland has been of the opinion that the optimum solution would have to cover all the flights, both to and from the EU as well as within the EU. As the text negotiated with the European Parliament does not provide a response to Polish concerns, yet endeavours to facilitate the global climate negotiations, Poland will abstain from voting."

Statement by the United Kingdom

"The British Crown Dependencies - the Isle of Man, the Bailiwick of Guernsey, and the Bailiwick of Jersey - recognise that the purpose of "stop the clock" is to improve the prospects of securing a global deal within the framework of ICAO in September 2013. The Crown Dependencies strongly support this objective. The Crown Dependencies also recognise that the inclusion of certain third countries (ie the Overseas and Dependent Territories, and the EEA/EFTA countries) is helpful for the EU's negotiating position ahead of the ICAO meeting.

For this reason, the Crown Dependencies are, exceptionally, prepared to accept continued inclusion within the EU ETS aviation scheme on the temporary basis set out in the Commission "stop the clock" proposal in order to maximise the chances of securing a global deal within the framework of ICAO.

However in the event of no global agreement being reached in September within the framework of ICAO, the UK supports the view of the Crown Dependencies governments that the exclusion of the dependent territories from the temporary derogation should not be treated as a precedent for any successor regime which may or may not be required after the expiry of the temporary measure.

In such an event (ie no global agreement in ICAO), the UK would expect the Commission to engage in full and timely consultations with all interested parties, including the Crown Dependencies, before submitting any proposal for a successor to the temporary "stop the clock" regime."

In particular, the Committee did not indicate flexibility with the proposed deadline for exemption of cadmium batteries and accumulators and with inter-institutional matters.

Following the exchange of views, which focused in particular on the Commission justification on explanatory documents (doc. 8394/13) and on the draft Commission declarations (advance copy in DS 1304/13), the Committee agreed for the Presidency to send the letter to the European Parliament together with the compromise text with a view to an agreement in first reading on this proposal.

As regards the recital (23a) on <u>explanatory documents and the justification</u> provided, the Commission:

- undertook, from now on, to respect the joint political declarations, by providing the justification in time to allow for a debate on the need to insert a recital on explanatory documents, in other legislative acts;
- confirmed the declaration made at the moment of the adoption of the joint political declarations on 28 September 2011 that "the political declarations on the explanatory documents as such do not provide a basis for launching infringement proceedings for the absence of such explanatory documents";
- reassured delegations as to the fact that any decision on the launch of infringement procedures is taken at political level by the College and is not triggered automatically if explanatory documents are not forwarded with the notification of transposition. The software presently in use will be checked and if contradictions become apparent they will be rectified.

As regards the <u>draft declarations</u>: the Commission took note of the concerns expressed by many delegations as regards its remarks on the legal suitability of provisions in Article 3 of the Directive.

The Council Legal Service, whilst recalling that the procedure in the joint political declaration had not been followed, said that the failure to provide explanatory documents would not in itself lead to a finding of infringement by the Court. Such a finding would depend on an actual breach of the Directive. As regards the Commission declarations, the CLS took the view that it was lawful to make the date of application dependent upon the existence of an objective circumstance, such as the availability of the technical guidelines. Finally, the CLS reiterated its disagreement with the view expressed by the Commission in relation to comitology and the "no opinion" clause.

Germany made the following statement:

"We agree with the Presidency proposal on Article 3 (1a)(ii) in document 8186/13. However, we would like to clarify our interpretation of this point once again.

Directive 2000/60/EC does not envisage notifying the Commission of the programmes of measures. The new requirement to submit the preliminary programmes of measures would constitute a special regulation for this substance group, which we reject in principle.

In order to reach agreement in the first reading, we accept the submission of the preliminary programme, whereby our understanding is that this programme will be kept general (in particular not be detailed to the water body level), and that there is no obligation to submit the final programme of measures.

Furthermore, the basic principle taken up in Article 3 of requiring the prevention of deterioration is already anchored in Directive 2000/60/EC and therefore superfluous here. Our agreement to Article 3 is made on the basis of the interpretation set out above."

- Ministers had a discussion on Europe's options for future growth based on a presentation by Bruegel.
- This was followed by the usual Eurogroup debrief by its Chair.
- Ministers then reached political agreement on lengthening maximum average maturities of the EFSF / EFSM loans to Portugal and Ireland by seven years.
- The main topic at the lunch was the SSM (Single supervisory mechanism). Ministers agreed on a statement by Member States declaring their readiness to work constructively on a proposal for a treaty change.
- Ministers had a discussion on the economic outlook and financial stability of the EU.
 They discussed growth prospects and the need to send a reassuring message to the markets.
- They then discussed the future shape of the banking union in the EU, with contributions from Jacques de Larosière and Dirk Schoenmaker.
 - One of the main discussions at the meeting was on taxation the action on tax transparency and tax fraud/evasion in the international context. Ministers and (Tax) Commissioner Semeta discussed recent tax developments.
- The Presidency then outlined its ambitious plans on financial services dossiers, setting out their priorities for the remaining three months of their presidency.
- Regarding financing options for long-term economic growth, the Presidency stressed the importance it attaches to the issues in the recent Commission Green Paper on long-term financing which, together with a presidency note, provided the basis for the discussion. Ministers agreed to ask the EFC to advance the work and consider the idea of drawing on a high level expert group.

• Finally, Ministers agreed on draft EU Terms of Reference and the draft IMFC Statement for the IMF/World Bank Spring and G20 Finance Ministers meetings on 18-19 April 2013 in Washington. The Commission and Presidency will send a letter to the ECOFIN to debrief on the outcome of the G20 ministerial meeting.
