- 1. On 8 March 2013, the Federal Republic of Somalia presented a request for accession to the ACP-EU Partnership Agreement<sup>1</sup>.
- 2. Article 94 of the ACP-EU Partnership Agreement provides that any request for accession by a State is to be presented to, and approved by, the ACP-EU Council of Ministers.

- On 8 May 2013 the Commission submitted to the Council a proposal for a Council Decision on the position to be adopted by the European Union within the ACP-EU Council of Ministers concerning the status of the Federal Republic of Somalia in relation to the ACP-EU Partnership Agreement<sup>1</sup>.
- 4. The ACP Working Party agreed the text of the draft Council Decision on 14 May 2013.
- 5. In accordance with Article 1 of the Internal Agreement for the implementation of the ACP-EU Partnership Agreement<sup>2</sup>, this decision should be adopted by the Council acting unanimously.
- 6. The Permanent Representatives Committee is accordingly invited to recommend that the Council, as an "A" item on its agenda:
  - adopt the draft Decision set out in document 9444/13 ACP 71 RELEX 390 COAFR 147
     OC 290 after finalisation by legal/linguistic experts;
  - order the publication of the abovementioned document in the Official Journal of the European Union.
