Report on the activities of the Customs Cooperation Working Party (1 July - 31 December 2012) doc. 7943/13 ENFOCUSTOM 54

3. Proposal for a Regulation on the European Union Agency for Law Enforcement Cooperation and Training (Europol) and repealing Decisions 2009/371/JHA and 2005/681/JHA

On the basis of a Presidency discussion paper set out in doc. 8899/13 JAI 317 CATS 17 ENFOPOL 122, the Committee had an extensive debate about some issues proposed in the above-mentioned draft Regulation.

In general, the interventions showed that delegations are happy with the current functioning of CEPOL and Europol and therefore do not wish to make any major changes that would endanger this.

A majority of delegations oppose the proposed merger of CEPOL into the new Europol, fearing that this would quickly endanger the importance of and resources for EU law enforcement training. At the same time, they see a risk that the merger would negatively affect the operational core business of Europol. Several delegations also indicated that the reasons for the merger were not sufficiently explained and even contradicted the evaluation ordered by the Commission. Furthermore they consider that no detailed calculations had been provided by the Commission which would allow to make a serious assessment as to the possible costs savings of a merger. A number of Member States also expressed reluctance regarding the proposal to make the transmission of information to Europol mandatory, explaining that the focus should be on quality of data rather than quantity and suggesting that incentives could work better than a legal obligation.

It was also pointed out that for Europol to be the information hub, reciprocity in information exchange with other EU bodies should be ensured. As regards the data protection regime for Europol, it was stated that the link should be made with the data protection package currently under negotiation.

The Chair took note of the strong misgivings regarding the proposed merger and concluded that this point would be submitted to Council for political guidance.

4. Report on the second joint review of the implementation of the Agreement between the European Union and the United States of America on the processing and transfer of Financial Messaging data from the European Union to the United States for the purposes of the Terrorist Finance Tracking Program
