- took note of the following unilateral statement by MT:

"The Republic of Malta has always supported the fight against match fixing and will continue to do so. In this regard, the Republic of Malta welcomes the Commission's participation in the creation of an international legal framework for the prevention of and fight against the manipulation of sports results, notably match-fixing.

Nevertheless it has to be pointed out that the Republic of Malta is still concerned that the mandate includes an unharmonised area of the internal market, gaming, within its scope. This is an area in which there is a certain amount of legal uncertainty. The Republic of Malta also regrets that the parameters of the mandate for the Commission to negotiate are in certain aspects still unclear.

The Republic of Malta stresses the need to ensure that while discussions on this draft Convention should not address sensitive political issues related to the legislation or regulation of gaming issues where there are no adopted rules at EU level, it believes in the added value of the Commission negotiating in order to ensure compliance with the internal market freedoms and in order to ensure that matters that do not directly relate to match-fixing are not covered by this Convention."
