3. Proposal for a Regulation of the European Parliament and of the Council on Animal Health

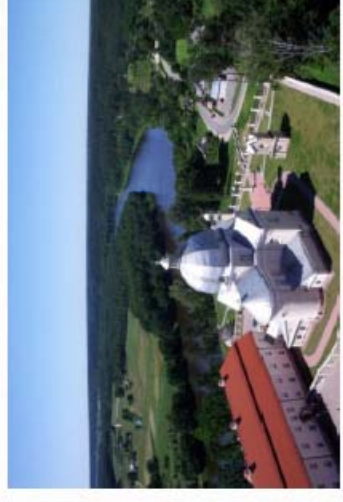
