1. The General Secretariat of the Council has been informed of the resignation of Mr Anastassios YIANNAKI, as alternate member of the Governing Board of the above Agency in the government representatives category (for Cyprus).
2. Under Article 8 of Regulation (EC) No 2062/94, as amended by Regulation (EC) No 1112/2005, members of the Governing Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EC) No 2062/94 of 18 July 1994 establishing a European Agency for Safety and Health at Work<sup>1</sup>, and in particular Article 8 thereof,

Whereas:

- (1) In its Decisions of 22 November 2010<sup>2</sup>, 7 March 2011<sup>3</sup>, 21 March 2011<sup>4</sup> and 18 July 2011<sup>5</sup>, the Council appointed the members and alternate members of the Governing Board of the European Agency for Safety and Health at Work for the period from 8 November 2010 to 7 November 2013.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Mr Anastassios YIANNAKI.
- (3) The government of Cyprus has nominated a candidate for the vacant seat,
