On 2 May 2013, the <u>Commission</u> submitted to the Council draft amending budget (DAB)
No 5/2013 regarding the mobilisation of the EU Solidarity Fund for a total amount of
EUR 14 607 942 in commitment and payment appropriations.

The objective of this proposal is to provide financial assistance to Slovenia, Croatia and Austria in response to flooding disasters that occurred in October and November 2012.

The corresponding appropriations are to be recorded under Article 13 06 01 (EU Solidarity Fund - Member States).

- 2. On 23 May 2013, the <u>Budget Committee</u> examined the Commission proposal and was able to accept it without any changes.
- 3. At the close of its examination, the <u>Budget Committee</u> agreed, by a qualified majority<sup>1</sup>, to suggest that the Permanent Representatives Committee advise the Council to:
  - adopt the Council's position on DAB No 5/2013 as set out in point 2;
  - approve the draft decision of the European Parliament and of the Council establishing amending budget No 5/2013 as set out in Annex 1 and transmit it to the European Parliament;
  - instruct the Presidency to prepare the budgetary documents to be sent to the European Parliament and to approve the draft letter in Annex 3 to that effect;
  - have the Council's position published in the *Official Journal of the European Union* as set out in Annex 2.
