Proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund in accordance with Point 28 of the Interinstitutional Agreement of

17 May 2006 between the European Parliament, the Council and the Commission on budgetary discipline and sound financial management (application EGF/2012/008 IT/De Tomaso Automobili from Italy)

Proposal for transfer of appropriations No DEC15/2013 within Section III -

1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 11820/13 FIN 390 SOC 557, accompanied by the corresponding proposal for transfer of appropriations No DEC15/2013, as recorded in document 11821/13 FIN 391.

Commission - of the general budget for 2013

2. The proposal aims at mobilising an amount of EUR 2 594 672 under the EGF to meet an application from Italy to deploy the Fund in connection with redundancies in the company De Tomaso Automobili S.p.A. The Italian car manufacturer has suffered from a constant decrease of EU market share in the world production of motor vehicles during recent years, arising from a strong competition from the major world car producers, in the context of major structural changes in world trade patterns.

The purpose of the proposed transfer is to move an amount of EUR 2 594 672 in commitment appropriations from Article 40 02 43 (*Reserve for the European Globalisation Adjustment Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*).

- 3. At the simplified trilogue procedure provided for in Point 28 of the Interinstitutional Agreement of 17 May 2006, an agreement was reached on the mobilisation of the EGF and on the amount proposed by the Commission.
- 4. The <u>Budget Committee</u> examined both proposals at its meeting on 9 July 2013.
- 5. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the proposed Decision on the mobilisation of the EGF;
 - approve the proposed transfer of appropriations;
 - approve the draft letter in the ANNEX to that effect.
