Dear Mr O'Huiginn,

We registered your request of 20 May 2013 for access to documents 7613/13 and 7613/1/13 REV 1. Thank you for your interest.

The General Secretariat of the Council has examined your request on the basis of Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents¹ (hereafter the "Regulation") and specific provisions of the Council's Rules of Procedure² and has come to the following conclusion:

Preliminary note:

EU classified information shall be classified at one of the following level, among others ³:

"RESTREINT UE/EU RESTRICTED": information and material the unauthorised disclosure of which could be disadvantageous to the interests of the European Union or of one or more of the Member States.

Document **7613/13 RESTREINT UE/EU RESTRICTED** and its revised version **7613/1/13 REV 1 RESTREINT UE/EU RESTRICTED** are cover notes from the European External Action Service (EEAS) to the Political and Security Committee and the European Union Military Committee containing respectively EEAS documents EEAS 00610/13 and EEAS 00610/1/13 REV 1 "*Op ALTHEA - Six Monthly Review Number 17, Non- paper on surplus munitions and weapons in BiH "*.

These documents are still being discussed and contain sensitive information on the way to address the issue of surplus munitions and weapons in BiH as well as internal situation assessments.

Release of this information would provide details on the progress achieved as well as on impediments in this process. It would affect relations with relevant third parties and undermine the efficiency of the action to be taken.

Accordingly, pursuant to Article 4(1)(a), second and third indents of the Regulation (protection of the public interest with regard with regard to defence and military matters and with regard to international relations), the General Secretariat is unable to accede to your request. The General Secretariat has also looked into the possibility of disclosing parts of the documents pursuant to Article 4(6) of the Regulation. However, as the information contained in the documents forms an inseparable whole, partial access cannot be granted.

Mr. Thomsen,

My thanks for your letter dated 10 June, refusing my application for documents 7613/13 and 7613/1/13 REV 1 (Op ALTHEA - Six Monthly Review Number 17, Non- paper on surplus munitions and weapons in BiH). I am submitting this confirmatory application, asking the Council to reconsider its decision not to release the documents.

You base your refusal on Article 4(1)(a), second and third indents of the Regulation (protection of the public interest with regard to defence and military matters and with regard to international relations).

These exceptions do not apply to the entire document. The ALTHEA six-monthly reporting process is specified in document 15188/04. This states that "the review can not be seen as a strictly military issue; all relevant EU actors in BiH must give their input during the review process"1.

As for international relations: the activities of EU actors in Bosnia (including national activities by member states) does not inherently fall under international relations. You must demonstrate that disclosure would harm relations with Bosnia or another foreign government.

In both categories the question is not whether the document *concerns* international relations, but whether *disclosure would undermine the protection of the public interest* in the relevant areas. It will not. The EU officials have already made highly critical public statements on the impediments to the decommissioning of surplus weapons in BiH. Given this, the publication of further details cannot be expected to further "affect relations with relevant third parties". For example, an EU representative recently told the UN Security Council that:

"Political deadlock in Bosnia and Herzegovina continues to burden the process of further stabilization....Difficulties at the entity level...complicate efforts to...implement reforms in the area of defence, including the necessity to resolve the problem of unstable stockpiles of surplus arms and ammunition in the country" 2

Even if disclosure did *affect* relations, it is not clear that the net effect would be negative. You do not justify your assertion that disclosure would "*undermine the efficiency of the action to be taken*" (which, in turn, is not the same as undermining the public interest).

In fact EU institutions have already decided that the public interest is furthered, not undermined, by discussion of the issue of surplus munitions. EU strategy on surplus munitions is set out in 5319/06. This calls for "public education and awareness", "promoting measures to improve transparency", and "improved exchange of information"3. EU-backed research has identified "a clear need for the public to be educated on the dangers small arms and light weapons can present to their well-being"4

Further, since this report is a compilation of input from "all relevant EU actors in BiH"5, it should not be considered an "inseparable whole". If full disclosure is impossible, please reconsider disclosing part of the document under Article 4(6)

I am requesting the document for the purpose of journalism, which is aligned with the public interest. The information will be used to educate the public in Bosnia and the EU about an important issue of public policy. This is particularly important when EU money is being spent on decommissioning weapons in Bosnia, both directly and through the UNDP6.

You write that 'these documents are still being discussed'. However, they were produced almost three months ago; responses were already circulated in April7. Considering that this report is one of a series published twice-yearly, I consider that enough time has been allowed for any secret discussions required. You make no claim that the discussions meet the test laid out in 1049/2001 – that they "would seriously undermine the institution's decision-making process"

To summarize:

- the document does not fall entirely under exempt categories of 1049/2001
- at least a partial release should be possible, given the nature of the document
- the public interest is best served by disclosure, because of the issues involved and EU policy on them, and because the request is for the purpose of public-interest journalism

I consent for this confirmatory application to be made public, in the Council Register of Documents or otherwise.
