<u>The Committee</u> confirmed the agreement on the package deal set out in the Annex to document 11422/1/13 REV 1 and mandated the Presidency to present the agreed text to the European Parliament at a first trilogue meeting on 26 June 2013. The Presidency will explore with the European Parliament ways for resolving the concerns of some delegations with regard to Article 8(4), concerning the creation and modalities for the functioning of Expert Teams, one of the eligible actions under Article 7 of the draft Regulation.

<u>The Committee</u> took note of the information given by the Presidency on the outcome of the informal trilogue held on 19 June 2013 and approved the overall compromise text as set out in 11237/13.

PL, HU and CZ announced that they could not support the text without a Council statement on climate change. As other delegations rejected this statement, HU and CZ indicated that they would vote against the adoption of this Decision. DE, FR, MT, NL, AT and UK entered the following statement to the minutes on soil protection:

"Germany, France, Malta, the Netherlands, Austria and United Kingdom support the outcome of the informal trilogues regarding a 7th EAP. Germany, France, Malta, the Netherlands, Austria and United Kingdom also proposed different improvements to the text and showed a maximum of flexibility throughout the negotiations. It is in the spirit of a compromise that we are able to support the wording of the proposed 7th EAP with regard to a Soil Framework Directive. However, Germany, France, Malta, the Netherlands, Austria and United Kingdom maintain the view that the proposed Directive of the European Parliament and of the Council establishing a Framework for the Protection of Soil and amending Directive 2004/35/EC as put forward by the European Commission in 2006 does not represent a proportionate, adequate and forward-looking instrument for soil protection at EU level.

National or regional approaches aimed at soil protection vary widely due to highly differentiated patterns of agriculture, forestry and land use. Albeit to varying degrees across the EU, progress has already been made to ensure soil protection, including contaminated site identification and the development of monitoring systems. Emphasis should be placed on strengthening these efforts by sharing best practice examples and further development of guidelines, taking full account of regional differences and the principles of subsidiarity and proportionality."

MT entered the following statement to the minutes on land:

"In the spirit of compromise, Malta supports the outcome of the informal trilogues on the Proposal on a General Union Environment Action Programme to 2020 "Living well, within the limits of our planet".

However, Malta is still concerned with respect to references to the setting of targets on land use found in paragraphs 23 and 26(v). The setting of key objectives for land use is already being discussed in the context of the Territorial Cohesion and Urban Development portfolios. Malta believes that the application of such targets should remain the prerogative of Member States in view of the specificities and diversities of territories."

A <u>number of delegations</u> requested additional time to enable them to scrutinise the consolidated document before they could take their final position on the file. Others indicated they could approve the outcome of the trilogue already then. <u>The Committee</u>, following a short exchange of views, agreed to temporarily defer the analysis of the final compromise text with a view to agreement.

<u>The Committee</u> approved by a qualified majority the compromise text set out in document 11500/13 ADD 1 and gave a mandate to the Presidency to confirm a first reading agreement by letter to the European Parliament. The compromise text was not supported by <u>BE, CZ, DE, AT</u> and <u>PT</u>. <u>UK</u> announced that its support was conditional to a written Commission statement confirming that the new wording in Article 22(1) would not change the current practice regarding increased controls in case of incompliances with the identification and registration provisions. The <u>Commission</u> representative gave an oral statement along these lines and expressed a positive initial attitude towards UK's request. He indicated, however, that the Commission preferred delegated powers in Article 13(6). The <u>Presidency</u> urged the Commission to act in a constructive way, given the agreement between the co-legislators on this point, and concluded that the letter to EP would not be sent before the Commission had confirmed its position in relation to these two issues.

#### Presidency statement on the Consultation Committee procedure (CoCo)

"The Presidency recommended to future Presidencies to look into the possibility of reviewing the consultation procedures concerning relations with staff, and emphasised the importance of such consultation. The Presidency also recommended that the Council should invite the other institutions to undertake similar reflections."

#### Commission statement on Pensions

"Even though the European Union pension scheme is structurally in balance through statutory mechanisms, the Commission shall continue to monitor the overall cost generated by these pensions in the short and in the long term and shall take all necessary steps encompassed in the Staff Regulations with regard to amending the pensionable age and the rate of contribution in order to ensure the sustainability of the pension scheme, and the link between life expectancy and the evolution of pension age, while respecting staff legitimate expectations."

#### Commission statement on Geographical Balance

"With regard to the sensitivity and the importance of geographical balance within the institutions, all measures to be taken by the Commission will be based on a thorough analysis which includes a reliable statistical assessment and a forecast on the likely evolution of geographical balance. All measures taken must be proportionate and, consequently, take into account the results of the above mentioned analysis, the objective of geographical balance, the principle of equal access to the European civil service as well as the principle of merit and the respect of multilingualism."

Following an exchange of views, the Committee:

- Validated the provisional agreements with the European Parliament on the sectorspecific regulations (ERDF, ETC and CF) set out in the Addenda 1, 2, 3 REV 1 and 5 to document 11375/13 and on the EGTC set out in Addendum 4 to document 11375/13, including the draft joint European Parliament, Council and Commission statements as set out in Annex 3 of Addendum 4 to document 11375/13 intended to be entered into the minutes of the Council adopting the legislative acts;
- Agreed on the EGTC that a "I" item note will be submitted to <u>the Committee</u> in the near future with a view to authorizing the President of <u>the Committee</u> to send a letter to the European Parliament in order to confirm that the compromise in the forth column of Annex 1 to document 11375/13 Addendum 4 can constitute the basis for a first reading agreement between the co-legislators;
- Agreed to the text of the revised Annex IIIbis on the allocation methodology from the MFF-related provisions of the common provisions regulation as set out in Addendum 11 to document 11375/13;

#### Article 54 on operations generating net revenue after completion:

"The Commission takes note of Member States' strong wish that flat rate revenue percentages for the sectors or subsectors within the fields of ICT, research, development and innovation, and energy efficiency are established as soon as possible pursuant to Article 54 of the common Provisions Regulation. The establishment of flat rates requires reliable and representative historic data in order to ensure a solid basis for the flat rate and to minimise the risks of over-financing. Consequently, the Commission will prepare the tender process for the launch of a study to collect and analyse the necessary data throughout the EU without waiting for the adoption of the legislative package, and will plan and manage the study, and draw the conclusions from its results so as to be able to adopt a delegated act setting out the flat rates for these sectors or subsectors at the earliest possible date and by 30 June 2015 at the latest."

#### Article 116 on non-statistical sampling:

"The Commission notes that the provisional agreement reached by the European Parliament and the Council in relation to the issue of non-statistical sampling under Article 116 provides that such a sample must cover at least 5 % of operations and 10 % of expenditure relating to the accounting year. It further notes that guidance issued by the Commission on sampling methods for audit authorities for the 2007-2013 period indicates that the sample size in the case of non-statistical sampling should generally be not less than 10 % of the population of operations. The Commission considers that the possibility of reduction in the size of the sample of operations to 5 % presents a risk that the sample will be insufficiently representative and will therefore have the effect of weakening the audit assurance." <u>Statement by Hungary</u> to the four column table on the preliminary outcome of the trilogues and technical meetings on the ERDF regulation

"On the basis of point 15 of Annex II to Regulation No 1083/2006/EC laying down general provisions on the European Regional Development Fund, the European Social Fund and the Cohesion Fund and repealing Regulation (EC) No 1260/1999 according to which for the Közép-Magyarország region "the same regulatory provisions would apply as for the regions referred to in Article 8(1)" of that regulation (i.e. phasing-out regions), Hungary considers that the thematic concentration requirements for this region in the 2014-2020 period are those set out in Article 4(1) of the preliminary outcome of the trilogies on the ERDF for the regions designated with the phasing-out status in the 2007-2013 period but which are eligible under the category of more developed regions."

#### Statements by Poland to :

"Technical Assistance

Poland considers that since Art. 109(4) relates to Structural Funds only and categories of regions are not applicable to the Cohesion Fund, Member States could decide, in accordance with Art. 109(2), to use up to 10% of the Cohesion Fund allocation to support technical assistance eligible under ERDF and ESF in any category of regions. Member States can use to this purpose a single priority axis, or several priority axes or a separate programme financed exclusively from the Cohesion Fund."

#### "ERDF & Cohesion Fund Regulations

Poland understands that investment priority "promoting the use of high-efficiency cogeneration of heat and power based on useful heat demand" includes support for construction and modernization of district heating and cooling networks."

## 65. Proposal for a Regulation of the European Parliament and of the Council on insider dealing and market manipulation (market abuse) (MAR) (First reading)

**Validation of the provisional agreement with the European Parliament** 11384/13 EF 137 ECOFIN 618 DROIPEN 81 CODEC 1567

<u>The Committee</u> confirmed the political agreement reached with the European Parliament, and agreed to enter into its minutes the following statement by the SE, DE, AT and CZ delegations:

"The provisional agreement means that administrative authorities will be able to access data traffic records held by providers of public electronic communications networks. This amounts to a serious interference with the right to respect of private and family life and the right to protection of personal data. Issues of privacy and surveillance are highly sensitive topics that need to be dealt with in a consistent manner across all EU policy areas. We welcome that the recitals clarify that Member States should have adequate and effective safeguards, i.e. prior judicial authorization, for the exercise of those powers. We would prefer that the requirement of adequate and effective judicial safeguards is reflected in the Article as well. In this context the opinion of the EDPS should be duly considered. Further, we assume, and strongly suggest that it is explicitly mentioned, that the access does not cover data retained for the purposes of Directive 2006/24/EC (the Data Retention Directive), as this would circumvent the requirement in the Data Retention Directive of retention only for the purposes of investigating, detecting and prosecuting serious crimes. Any expansion in the access to traffic data outside judicial procedures would set a dangerous precedent for other EU dossiers."

66. Proposal for a Regulation of the European Parliament and of the Council on key information documents for packaged retail investment products (PRIPs) (First reading)
General approach

Following a discussion, <u>the Committee</u> reached an agreement on the general approach and mandated the Presidency to pursue negotiations with the EP on the basis of that general approach.

Member States made the following statements:

#### Statement by Italy and Greece

"Italy and Greece would like to thank the Presidency's efforts to reach an agreement on the proposal of Regulation on Packaged Retail Investment Products. Despite acknowledging that important improvements have been included in the Presidency compromise text, Italy and Greece are still concerned that the current definition of the scope, as contained in Art. 2(ac) concerning life insurance products, may create uncertainties in the application of the Regulation. Furthermore, the possibility provided for the Member States not to lay down administrative sanctions will not ensure, from Italy and Greece's point of view, the desired harmonization of the sanctioning regime for breaches of the PRIPs Regulation.

Italy and Greece therefore expect that these subjects can be revisited during the negotiations with the European Parliament in order to achieve greater clarity for the application of the Regulation and a more effective and harmonised regulatory regime."

#### Statement by Germany and United Kingdom

"Germany and the UK support the Presidency in trying to move forward the discussion on key information documents for packaged retail investment products. Therefore we will not object the proposed compromise text of the regulation.

Nevertheless it is in our point of view necessary to improve the scope of the regulation in regard of effective investor's protection and a European level playing field for investment products. The PRIPs initiative will only achieve its investor protection objective and rebuild consumer confidence with all substitutable and comparable products in scope. In the case of the exclusion of life insurance products which may provide a variable bonus or surplus yield from the scope we do not consider the exclusion of these products appropriate. Excluding these products invites arbitrage and undermines the main purpose of the regulation, which is to ensure that retail investors receive a uniform disclosure document regardless of the legal form of the investment. We expect that this issue will be revisited during the trilogues with the European Parliament."

#### Statement by Austria

"The Austrian constitutional law presently does not allow for administrative pecuniary sanctions in the amount provided for in Article 19 para 2 lit f (i) (a) and (ii) (a). Therefore, we cannot currently commit to the implementation of this provision, as implementation would require an amendment to constitutional law. It is not predictable whether such an amendment to the Constitution will be adopted."

#### Statement by France

"Despite improvements brought by the Presidency, France cannot approve of the compromise text due to the fact that it still provides an option for Member States not to lay down rules for administrative sanctions where breaches to the proposed regulation are subject to criminal sanctions in their national law. In this Regulation and beyond, such an option would not be appropriate for legislation relating to rules of conduct or investor disclosure documents for which a strong, harmonised and effective regime of administrative sanctions is essential. France expects these subjects to be revisited during the negotiations with the European Parliament to achieve a more effective and harmonised regime."

#### 67. Draft amending budget No 1 to the general budget for 2013

<u>The Committee</u> reached an agreement on draft amending budget No 1/2013 and the revision of the multiannual financial framework 2007-2013 to take account of the expenditure requirements resulting from the accession of Croatia to the European Union on the basis of the Presidency proposal set out in document 9195/13. The resulting documents (11586/13 and 11588/13) will be submitted as "A" items to the Ecofin Council on 26 June 2013 for formal adoption.

<u>The Committee</u> adopted the following statement which is entered in its minutes:

"The <u>Council</u> being firmly dedicated to ensure an orderly accession of Croatia has adopted amending budget No 1/2013 covering the financial commitments for 2013 given to Croatia in the accession treaty. Fulfilling its obligations and respecting the Interinstitutional Agreement on budgetary discipline and sound financial management of 17 May 2006 and the Council Declaration on the Financial and Budgetary Provisions for Croatia's Accession to the EU of July 2011, the Council has also adopted a revision of the commitment ceilings for budget headings within the overall ceiling for commitment appropriations and a revision of the payment ceiling in 2013 of EUR 374 million.

The decision to revise the payment ceiling by EUR 374 million is on the basis that this increase is only used for programmes related to Croatia after its accession. As part of its consideration of any further amending budget, the Council will require an update on the implementation of programmes related to Croatia.

The decision to revise the payment ceiling does not prejudge the Council position on possible proposals for further amending budgets in the course of 2013. The Council, in this regard, recalls the provisions of the Financial Regulation and urges the Commission to actively manage the EU budget over the rest of 2013 in a prudent way and to continue to try to fund additional needs by redeployment in the first instance."

#### 68. Follow-up to the Council meeting (Economic and Financial Affairs) on 21 June 2013

At the breakfast, Ministers were debriefed from the <u>Eurogroup</u>. This was followed by an exchange of views on the <u>economic situation</u>.

The President of the European Investment Bank briefly raised issues related to the <u>Commission/EIB report to the European Council</u>.

The Council approved the 23 country-specific recommendations, a recommendation for the euro-area as whole, and the comply or explain note. The Council also adopted Council conclusions on Croatia.

On the implementation of the <u>Stability and Growth Pact</u> item, the Council adopted 15 Council Decisions and Recommendations on excessive deficits.

The Commission and EIB presented their Joint Report to the European Council.

The Council adopted the Decisions on extending the maturities of EFSM loans to Ireland and Portugal.

Regarding the <u>adoption of the euro by Latvia</u>, there was an exchange of views on the ECB/Commission convergence reports. The Council adopted the Recommendation by the euro area Member States that Latvia fulfils the criteria and the Council approved a letter from the Council (ECOFIN) President to report on this to the European Council.

Poland raised the issue of the follow-up to the May European Council as regards the integration of economic, <u>climate and energy</u> policy.

The Council endorsed <u>a report</u> to the European Council on tax issues. A Report on tax issues was also endorsed by Ministers in the framework of the Euro Plus Pact.

The Commission presented a proposal regarding the mandatory <u>automatic exchange of</u> <u>information</u> in the field of taxation.
