Subject:	Proposal for a Council Regulation amending Regulation (EC) No 659/1999 laying down detailed rules for the application of Article 93 of the EC Treaty - Adoption

 On 6 December, 2012, the <u>Commission</u> submitted to the Council a proposal for a Council Regulation amending Regulation (EC) No 659/1999 laying down detailed rules for the application of Article 93 of the EC Treaty (Procedural Regulation), based on Article 109 TFEU.

- 2. The proposal is part of a comprehensive reform of the State aid framework launched by the Commission Communication on "*EU State aid modernisation (SAM)*" on 8 May 2012 with a view to ensuring that State aid policy contributes both to the implementation of the Europe 2020 agenda² and to budget consolidation.
- 3. The proposal aims at more efficient and transparent procedures as regards State aid by increasing the quality of the complaints submitted to the Commission, improving the efficiency and reliability of the Commission's data-gathering process and reinforcing the existing cooperation between the Commission and national courts.
- 4. On 29 May 2013, the <u>Competitiveness Council</u> adopted a general approach on the proposal.
- 5. On 2 July 2013, the <u>European Parliament</u> adopted its opinion on the proposal (consultation procedure in accordance with Article 109 TFEU) which is broadly in line with the Council's general approach.
- 6. The <u>Permanent Representatives Committee</u> is therefore asked to confirm the general approach and to suggest that the Council:
 - adopts, with the Belgian, Hungarian and Austrian delegations voting against, the
 Proposal for a Council Regulation amending Regulation (EC) No 659/1999
 laying down detailed rules for the application of Article 93 of the EC Treaty, as
 set out in doc. 11139/13, as an "A" item at a forthcoming meeting;
 - orders that the statements in the <u>addendum</u> to this note be entered in the minutes of that meeting.
