Statement by Sweden

"Sweden does not believe there is justification for additional funding for the support scheme for specific measures for agriculture in the Union's outermost regions. Sweden cannot accept the increase in expenditure envisaged by the proposal, and therefore intends to vote against."

The Council took note of delegations' views on the Presidency paper on the basic payment scheme (doc 6638/13), as well as of the comments made by the Commission representative. The Council further took note of the Presidency's conclusion that the paper was a good basis towards Council reaching a position on the issue and of the Presidency's intention to further reflect with a view to making decisive progress at the next session of the Council ("Agriculture and Fisheries") on 18-19 March 2013.

The Council accepted the legitimacy of reinforcing public control of the use of the money from the European Agricultural Guarantee Fund and the European Agricultural Fund for Rural Development and agreed that the means proposed by the Commission to achieve that objective were appropriate and proportionate.

6. Proposal for a Regulation of the European Parliament and of the Council on the **Common Fisheries Policy [First Reading]**

The Council finalised the general approach on the proposal for a Regulation of the Common Fisheries Policy, focusing on the roll-out and modalities of the obligation to land all fish species which are managed through catch limits or, in the case of the Mediterranean Sea, minimum landing sizes (doc. 11322/1/12 REV 1 PECHE 227 CODEC 1657). Council and Commission together made a statement on the need to have implementation details in place when the landing obligations start applying in the fisheries (doc. 11322/1/12 REV 1 ADD 1 PECHE 227 CODEC 1657). The Commission welcomed the agreement reached by Council, expressing doubts about the maximum levels of de minimis discards and about the transitional regime allowing over-quota landings under certain conditions. The Commission reassured delegations that fishermen would not be left alone with the fundamental change of the rules. In particular, significant financial assistance from the Union would be available for pilot projects aimed at avoiding unwanted fish in the catch and for investments that would allow storage and marketing of species that used to be returned to the sea.

All Member States except Sweden supported the Council's general approach.
