COMMISSION DECISION

of 15.7.2013

amending Decision C (2005) 2754 prolonging the terms of office of the European Coordinators for certain trans-European transport network projects

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Decision No 1692/96/EC of the European Parliament and of the Council of 23 July 1996 on Community guidelines for the development of the trans-European transport network¹, and in particular Article 17a(1) thereof,

Having regard to the opinion of the European Parliament,

Whereas:

- (1) Decision No 1692/96/EC, as amended by Decision No 1346/2001/EC, Decision No 884/2004/EC and Council Regulation (EC) No 1791/2006, identifies projects of common interest designed to contribute to the development of this network and declares 30 priority projects, defined in Annex III, to be of European interest, including the projects to which both the Essen European Council in 1994 and the Dublin European Council in 1996 attached special importance.
- (2) Under Article 17a of Decision No 1692/96/EC, as amended, the Commission may designate, in agreement with the Member States concerned, and after having consulted the European Parliament, European Coordinators to facilitate the coordinated implementation of certain projects, in particular cross-border projects or parts of projects included among the projects declared to be of European interest.
- (3) The coordination mechanism introduced by means of Decision C (2005) 2754, as amended, which makes it possible to closely monitor the progress made on specific projects and to have a better overview of the work and which also aims to make it easier to complete the projects within the time-scale laid down by Decision No 1692/96/EC, as amended, for the sections of the priority projects, has proved to be successful.
- (4) Decision C (2009) 5706 and Decision C(2010) 3558, both amending Decision C (2005) 2754, prolonged the mandates of all previously appointed European Coordinators until 22 July 2013 and appointed new Coordinators in agreement with the Member States and in accordance with Article 2 of Decision C (2005) 2754.

- (5) The Commission proposal of 19 December 2011 for a Regulation of the European Parliament and of the Council on Union guidelines for the development of the trans-European transport network² provides for a new regime regarding the European Coordinators. This new regime should enter into force on 1 January 2014 at the latest.
- (6) In order to avoid short-term nominations and to ensure the continuity of the mandates until the new nominations can be pronounced on the basis of this new regime, the current mandates of all the European Coordinators should be prolonged until 31 December 2013 with the exception of the mandate of the Coordinator for priority project No 22 who will end his function on 22 July 2013. A new Coordinator for priority project No 22 should be nominated at a later date.

HAS DECIDED AS FOLLOWS:

Article 1

The Annexes to Decision C (2005)2754, as last amended by Decision C (2010)3558, shall be replaced by the Annexes to this Decision.

Article 2

The terms of office of the European Coordinators listed in Annex I shall be prolongued until 31 December 2013.

On the basis of Commission Decision [...], the European Union has designated you as European Coordinator for the priority project/s defined in Annex I to this Decision pursuant to Article 17a of Decision No 1692/96/EC of the European Parliament and of the Council of 27 July 1996 on Community guidelines for the development of the trans-European transport network³, as amended by Decision No 884/2004/EC.

Your task as a European Coordinator will be extended for the period from 23 July 2013 until 31 December 2013.

Your duties, which stem from those defined by the European Parliament and the Council, will chiefly include:

 the promotion of joint project evaluation methods approved in advance by the Commission and the provision, where necessary, of technical expertise to the project promoters regarding the financial package for the projects;

- the drawing-up of an annual report for the Commission, for transmission to the European Parliament and the Member States concerned, on the progress made in implementing the project, new regulatory or other developments which may affect the characteristics of the projects, and any difficulties or obstacles likely to cause serious delay affecting the completion dates agreed by the European Parliament and the Council. This report may also be used by the Commission to authorise the extension of aid programmes;
- consultation, together with the Member States concerned, of regional and local authorities, operators and users of means of transport, as well as representatives of civil society in order to better define transport demand, the possibilities of investment funding and the type of services to be provided to facilitate access to such funding;
- if requested by the Commission, the preparation of an opinion during the examination of requests for European Union funding concerning projects or groups of projects covered by your task.

More particularly, the Commission requests you to monitor

- financial decisions and report any problems with implementing them;
- compliance with environmental legislation and consideration of regional aspects; and
- compliance with the global corridor approach.

During the performance of your task you may not make commitments on behalf of the Commission without its prior written agreement. Subject: Mission statement for Mr Karel Vinck as European coordinator <u>for the</u> ERTMS project and the railway corridors

Dear Mr Vinck,

On the basis of Commission Decision C (2005) 2754, the European Union designated you as European coordinator for the project to deploy the ERTMS railway traffic management system in the railway corridors. Designation is made pursuant to Article 17a of Decision No 1692/96/EC of the European Parliament and of the Council of 27 July 1996 on Community guidelines for the development of the trans-European transport network⁴, as amended by Decision No 884/2004/EC.

The project to deploy the ERTMS railway traffic management system in the railway corridors is particularly important in order to give fresh impetus to the Europe 2020 strategy given the importance of the project for ensuring interoperability in the key railway corridors to allow for high-speed passenger and goods services and the massive industrial scale of the project.

The project is affected by difficulties relating to coordination between the Member States. These difficulties are delaying the development of a coherent strategy for deploying the system at European level. The strategy must implement the regulatory obligations regarding ERTMS arising from the high-speed interoperability directives while placing deployment in the wider context of developing the infrastructure of the major European rail corridors.

This two-fold objective, which is clearly set out in a Memorandum of Understanding between the Commission and the associations which represent the rail industry, is designed to promote new, more competitive high-quality railway services for both passengers and freight.

Your task is therefore very important to help the Commission in the context of the programming of funding and political dialogue with the Member States to enable the latter to overcome these difficulties.

Your task as a European Coordinator will be extended for the period from 23 July 2013 until 31 December 2013.

Your duties, which stem from those defined by the European Parliament and the Council, will chiefly include:

guiding the development of appropriate methodological approaches to establish the requirements for the implementation of ERTMS in all the rail corridors described in Annex H to the Technical Specification on Interoperability (TSI) for conventional rail. These reference methods will take account of the wider perspective as regards the supplementary requirements for the development of these corridors to guarantee their long-term commercial competitiveness;

- supervising the necessary studies being carried out corridor by corridor and integration of
 these studies into a coherent European Union plan for the deployment of ERTMS. This
 must take account of the specific requirements identified in the Memorandum of
 Understanding and the requirements of the Member States in their national plans for the
 deployment of ERTMS;
- contributing to the development of a coherent strategy for the implementation of this European plan, in particular by identifying the financial packages possible and any risks which might affect implementation;
- developing a set of supplementary development measures deemed to be necessary in all of these corridors to guarantee their long-term commercial performance objectives;
- chairing the high-level steering group provided for in the Memorandum of Understanding;
- the drawing-up of an annual report for the Commission, for transmission to the European Parliament and the Member States concerned, on the progress made in implementing the project, new regulatory or any other developments which may affect the characteristics of the projects, and any difficulties or obstacles likely to cause serious delay;
- regular consultation of all the Member States and players concerned in order to identify all
 factors relating to the development of the ERTMS rail corridors, the possibilities for
 funding the investments deemed to be necessary and the means of gaining access to such
 funding.
