STATEMENTS regarding Regulations 472/2013 and 473/2013			
Statement by the United Kingdom			
The UK reiterated its clear understanding that there would be no new commitments from the European Financial Stabilisation Mechanism (EFSM) following entry into force of the European Stability Mechanism (ESM) Treaty on 27 September 2012, recalling the commitment in the European Council Decision of 25 March 2011, which states that as the ESM is designed to safeguard the financial stability of the euro area as whole, Article 122(2) of the TFEU will no longer be needed for such purposes. The Heads of State or Government therefore agreed that it should not be used for such purposes.			

Statement by the European Commission

Once legislation proposed by the Commission on the two-pack is adopted, the Commission intends to take steps in the short-term towards a deep and genuine EMU as outlined in the blueprint. Short-term steps (6 to 12 months) will include:

- In its Blueprint for a Deep and Genuine EMU, the Commission considered that, in the medium-term, a redemption fund and eurobills could be possible elements of deep and genuine EMU under certain rigorous conditions. The guiding principle would be that any steps to further mutualisation of risk must go hand-in-hand with greater fiscal discipline and integration. The required deeper integration of financial regulation, fiscal and economic policy and corresponding instruments must be accompanied by commensurate political integration, ensuring democratic legitimacy and accountability.

The Commission will establish an Expert Group to deepen the analysis on the possible merits, risks, requirements and obstacles of partial substitution of national issuance of debt through joint issuance in the form of a redemption fund and eurobills. The Group will be tasked to thoroughly assess, what could be their features in terms of legal provisions, financial architecture and the necessary complementary economic and budgetary framework. Democratic accountability will be a central issue to be considered.

The Group will take into account the on-going reform of the European economic and budgetary governance and assess the added value for such instruments in this context. The Group will pay particular attention to recent and on-going reforms, such as the implementation of the two-Pack, the ESM and any other relevant instruments.

In its analysis the Group will pay particular attention to sustainability of public finances, to the avoidance of moral hazard, as well as to other central issues, such as financial stability, financial integration and monetary policy transmission.

The members of the Group will be experts in law and economics, public finances, financial markets and sovereign debt management. The Group will be invited to present its final report to the Commission not later than March 2014. The Commission will assess the report and, if appropriate, make proposals before the end of its mandate.

An exploration of further ways within the preventive arm of the Stability and Growth Pact to accommodate under certain conditions, non-recurrent, public investment programmes with a proven impact on the sustainability of public finances made by the Member States in the assessment of their Stability and Convergence Programmes; this will be done in spring-summer 2013 in the context of the publication of its Communication on calendar of convergence towards the Medium-term Objective;

- After the decision on the next Multi-annual Financial Framework for the EU and before the end of 2013, the Commission will to put forward the following proposals to complement the existing framework for economic governance: (i) measures to ensure greater ex-ante coordination of major reform projects and (ii) the creation of a "convergence and competitiveness instrument" to provide financial support for the timely implementation of sustainable growth enhancing structural reforms. This new system, fully in line with the Community method, would build on the existing EU surveillance procedures. It would combine deeper integration of economic policy with financial support and thereby respect the principle according to which steps towards more responsibility and economic discipline are combined with more solidarity. It would in particular aim at enhancing the capacity of a Member State to absorb asymmetric shocks. This instrument would serve as the initial phase towards the establishment of a stronger fiscal capacity.
 - Furthermore, the Commission commits to following up in a speedy and comprehensive manner on: (i) its action plan to strengthen the fight against tax fraud and tax evasion, in particular with view to the revision of the directives identified in the action plan as well as on (ii) the measures and proposals announced by the Commission on its 2012 package on the employment and social policy area.
 - Following the adoption of the Single Supervisory Mechanism, the presentation of a proposal for a Single Resolution Mechanism, which would be in charge of the restructuring and resolution of banks within the Member States participating in the Banking Union;
 - Before the end of 2013, the presentation of a proposal under Article 138(2) TFEU to establish a unified position to achieve an observer status of the euro area in the IMF executive board, and subsequently for a single seat.
- Building on the short-term steps announced in its Blueprint that can be realised by secondary legislation, the Commission is committed to put forward explicit ideas for Treaty changes in time for a debate before the next European Parliament elections in 2014 with a view to setting the legislative basis for the steps envisaged in the medium-term, which foresees the creation of a substantially reinforced economic and budgetary surveillance and control framework, a further developed European fiscal capacity supporting solidarity and the implementation of sustainable growth enhancing structural reforms, as well as the deeper integration of decision making in policy areas like taxation and labour markets as an important solidarity instrument.

STATEMENTS regarding Decisions 267/2013 and 268/2013

Statement by the European Commission

The Commission regrets that the Council excluded from the scope of the Decision the amendment to the Supplemental A and B Forms to the International Oil Pollution Prevention (IOPP) Certificate, which are required by international law to be kept on board of the ships. Given that Directive 2009/16/EC requires the Port State Control officers to check these specific forms in their up-to-date version, the Commission considers that the suggested amendment affects Union law.

Statement by the Netherlands

In order to safeguard the interests of the European Union, the Netherlands votes in favour of the proposed Council Decision on the position to be adopted, on behalf of the European Union, at the International Maritime Organization (IMO) with regard to the adoption of certain Codes and related amendments to Conventions, as well as of the proposed Council Decision on the position to be adopted on behalf of the European Union at the 65th session of the Marine Environment Protection Committee of amendments to forms A and B of the International Oil Pollution Prevention Certificates and amendments to the Condition Assessment Scheme and at the 92nd session of the Maritime Safety Committee of amendments to the International Safety Management Code and amendments to SOLAS chapter III and the High Speed Craft Codes 1994 and 2000 concerning enclosed space entry and rescue drills.

While the Netherlands is in favour of a pragmatic approach according to our duty of loyal cooperation and to safeguard the interests of the European Union, this vote in this specific case, cannot be interpreted as a relinquishment of our original position in the case pending. Neither does this set a precedent for similar cases where the competence for external representation has become an issue.

It should therefore be made abundantly clear that the arrangements under this proposal are without prejudice to the division of competences between the European Union and its Member States and that this vote cannot be interpreted in any way as an acceptance of article 218(9) TFEU as an appropriate legal basis for these Council Decisions.

Statement by Germany

Article 218(9) of the Treaty on the Functioning of the European Union (TFEU) is given as the (procedural) legal basis for the proposal for a Council Decision on the position to be adopted, on behalf of the European Union, at the International Maritime Organization (IMO) with regard to the adoption of certain Codes and related amendments to conventions and protocols, and for the proposal for a Council Decision on the position to be adopted on behalf of the European Union at the 65th session of the Marine Environment Protection Committee on amendments to the Condition Assessment Scheme and at the 92nd session of the Maritime Safety Committee on amendments to the International Safety Management Code and amendments to SOLAS chapter III and the High Speed Craft Codes 1994 and 2000 concerning enclosed space entry and rescue drills. The Federal Government has misgivings about the use of this legal basis for the Decisions.

The Article 218(9) TFEU procedure does not apply to the coordination of EU Member States' positions in international organisations to which only the Member States, but not the EU itself, belong. The EU itself is not a member of the IMO. Only the EU Member States belong to the IMO. Since the EU is not a member of the IMO, these are not the decisions of an international organisation with legal effects for the EU, which is the condition set out in the wording of the provision.

The Federal Government points out that the Federal Republic of Germany has taken legal action at the Court of Justice of the European Union against a Decision based on Article 218(9) TFEU in a similar case (Case C-399/12).

In terms of content, the positions taken by Germany at the IMO will accord with those agreed in the Council Decision, but will be without prejudice to the misgivings about the legal basis expressed in this statement or to Germany's views in the above proceedings at the Court of Justice of the European Union.

Statement by Greece

Greece endorses the content of the texts of the two Council Decisions (Proposal for a Council Decision on the position to be adopted, on behalf of the European Union, at the International Maritime Organisation with regard to the adoption of certain Codes and related amendments to conventions and protocols and Proposal for a Council Decision on the position to be adopted on behalf of the European Union at the 65th session of the Marine Environment Protection Committee on amendments to the Condition Assessment Scheme and at the 92nd session of the Maritime Safety Committee of amendments to the International Safety Management Code and amendments to SOLAS chapter III and the High Speed Craft Codes 1994 and 2000 concerning enclosed space entry and rescue drills), as these texts were drafted during the negotiation in the Council and therefore Greece will support the EU positions in the context of the IMO.

Nevertheless, while Greece is in favour of a pragmatic approach according to our duty of loyal cooperation as an EU Member State, we still maintain our reservation regarding Article 218(9) TFEU as the appropriate legal basis for the Council decisions in question, establishing the position to be adopted on behalf of the European Union and the subsequent procedure for coordination between the EU Member States in the IMO.

In addition, Greece considers that the aforementioned procedure must not set a precedent for similar cases, where the competence for external representation of the EU Member States in the IMO or in other International Organisations has been or will become an issue.

Statement by Cyprus

Cyprus, for the purpose of enabling the International Maritime Organisation (IMO) to make progress on matters within its mandate and in the interest of enhancing safety and security at sea and the protection of the environment, does not oppose to the adoption of the proposed Council Decisions concerning the positions to be adopted by the Member States of the Union during:

(1) the 65th and 66th sessions of the Marine Environment Protection Committee of IMO, the 92nd and 93rd sessions of the Maritime Safety Committee of IMO and the 28th regular session of the Assembly of IMO in relation to:

(a) the adoption of an IMO Instruments Implementation Code;

(b) the adoption of an IMO Code for Recognised Organisations;

(c) the adoption of amendments to certain international conventions and protocols for which the Secretary-General of IMO performs depository functions through which the aforesaid codes and the IMO Member States Audit Scheme will be made mandatory; and

(d) the acceptance of aforesaid amendments in accordance with the respective provisions of the conventions and protocols concerned;

(2) the 65th session of the Marine Environment Protection Committee of IMO in relation to the Condition Assessment Scheme; and

(3) the 92nd session of the Maritime Safety Committee of IMO in relation to the adoption of amendments to the International Safety Management Code and to chapter III of the International Convention for the Safety of Life at Sea 1974, as amended, to the 1994 and 2000 High Speed Craft Codes and to the Dynamically Supported Craft Code concerning entry into enclosed spaces and related rescue drills.

However, Cyprus would like to stress and place it on record that the non opposition of Cyprus to the proposed Council Decisions, shall not, and cannot, be considered or construed as creating or being any form of a precedent and it is without prejudice to the views or positions Cyprus may opt to express or adopt in the context of the outcome of the case pending before the European Court of Justice in relation to the applicability of the provisions of Article 218(9) of the Treaty on the Functioning of the European Union.
