### Having regard to the November 2011 Council conclusions:

- A. How do you assess the progress and achievements, since November 2011, as regards the strengthening of the EU external energy policy?
- B. What further actions would you consider are needed to achieve the aims and targets as described in the Council conclusions of November 2011?
   Do you consider that any of the existing policies or initiatives need strengthening or improvement? If yes, please specify.
- N.B. Delegations may choose to either answer the above questions in a general manner (whilst possibly highlighting specific issues of their choice) or answer these questions in the context of the following areas (*i.e.* corresponding to the headings of the November 2011 Council conclusions):
  - 1. Strengthening the coordination of the external dimension of the EU energy policy
  - 2. Strengthening the EU cooperation with third countries Building on the internal energy market
    - Multilateral instruments
    - Infrastructures
    - Priorities for market integration
    - Global safety and security
  - 3. Deepening energy partnerships
  - 4. Supporting developing economies
